


2.6.2 The Ferron Coals will be the only gas and water bearing formations. The depth to the top coal formation is expected to be 1575', and the depth to the top of the lower coal formation is expected to be 1658'. 5-1/2" 17# K55 casing will be run and cemented with 200 sacks light cement and tail-in with 100 sacks class "A".

2.6.3 A double gate 3000 psi BOPE will be used with a rotating head. This equipment will be tested to 2100 psi or 70% of the minimum internal yield pressure. All test will be recorded in a Driller Report Book. Physical operation of BOP's will be checked on each trip. See Attachment #3 for Schematic.

from Coalbed Gas Recovery Wells

Dear Mr. Farrens:

We have reviewed your August 7, 1991 letter requesting permission to discharge coalbed gas recovery water to Drunkards Wash near Price. As indicated in the August 9, 1991 conversation with Steven McNeal, this type of water with high total dissolved solids concentrations is not considered acceptable for coverage by a general permit. Furthermore, the Colorado River Basin Salinity Control Forum policies and the state's anitdegration policy may preclude issuance of an individual permit.

An injection well or disposal pond regulated by the Division of Oil, Gas & Mining are the usual disposal methods for high TDS water from gas wells. You should contact their office if you desire to pursue one of those alternatives. Other alternatives such as, land application or evaporation ponds, etc., may be considered, however, they would be subject to applicable groundwater permitting requirements.





PROBABLE MINERAL COMPOSITION






