



2.6.2 The Ferron Coals and lower Ferron Sandstone will be the only gas and water bearing formations. The projected interval of the Ferron is 2045-2145 feet. 5-1/2" 17# WC75 casing will be run and cemented with 250 sacks light cement and tail-in with 100 sacks class "A".

2.6.3 A double gate 3000 psi BOPE will be used with a rotating head. This equipment will be tested to 2100 psi or 70% of the minimum internal yield pressure. All tests will be recorded in a Driller's Report Book. Physical operation of BOP's will be checked on each trip. See Attachment #3 for Schematic.

REGIONAL SETTING/TOPOGRAPHY

Site is located on a flat within a huge plain sloping gradually to the southeast.

CURRENT SURFACE USE: Livestock grazing. Deer and elk winter habitat.

PROPOSED SURFACE DISTURBANCE: Location is approximately 200' by 250'. Reserve pit and access road.

SURFACE GEOLOGY

SOIL TYPE AND CHARACTERISTICS: Silty shale, aluvium, light tan to light gray.

SURFACE FORMATION & CHARACTERISTICS: Weathered Mancos shale, Medium to dark, with occasional seams of siltstone and fine sandstone.

EROSION/SEDIMENTATION/STABILITY: Some erosion, minor sedimentation. No stability problems. Erosion could be a problem if location is not bermed.



Gentlemen:

Pursuant to Utah Code Ann. § 40-6-18, (1953, as amended), Utah Admin. R. 649-2-3, Application of Rules to Unit Agreements and R. 649-3-4, Permitting of Wells to be Drilled, Deepened or Plugged-Back, approval to drill the referenced well is hereby granted.
