2.3 This gas well will be drilled in a Federal Unit. The Unit name is Drunkards Wash Unit. The Unit No. is UTU 67921X.

2.6.1 The following geologic units are expected to be penetrated in the well.

2.6.2 The Ferron Coals and lower Ferron Sandstone will be the only gas and water bearing formations. The projected interval of the Ferron is 1760-1860 feet. 5-1/2" 17# WC75 casing will be run and cemented with 250 sacks light cement and tail-in with 100 sacks class "A".

2.6.3 A double gate 3000 psi BOPE will be used with a rotating head. This equipment will be tested to 2100 psi or 70% of the minimum internal yield pressure. All tests will be recorded in a Driller's Report Book. Physical operation of BOP's will be checked on each trip. See Attachment #3 for Schematic.



WELL & PIPELINE MAP



REGIONAL SETTING/TOPOGRAPHY

Site is located on a low ridge running east to west. There is a gradual slope to the south with a slightly steeper slope to the north. No gullies on or near site.

LAND USE:

CURRENT SURFACE USE: Livestock grazing. Deer and elk winter habitat.

PROPOSED SURFACE DISTURBANCE: Location is approximately 200' by 250'. Reserve pit and access road.

AFFECTED FLOODPLAINS AND/OR WETLANDS: None. This location would be an active water drainage only in the event of a flash flood.

FLORA/FAUNA: Salt brush, sage, native grasses, shad scale, prickly pear, greasewood. Rabbits, coyotes, reptiles, small indigenous birds, raptors, deer and elk in winter.

ENVIRONMENTAL PARAMETERS

SURFACE GEOLOGY

SOIL TYPE AND CHARACTERISTICS: Silty shale, aluvium, light tan to light gray.

SURFACE FORMATION & CHARACTERISTICS: Weathered Mancos shale, Medium to dark, with occasional seams of siltstone and fine sandstone.

EROSION/SEDIMENTATION/STABILITY: Some erosion, minor sedimentation. No stability problems. Erosion could be a problem if location is not bermed.

PALEONTOLOGICAL POTENTIAL: None observed at site.

SUBSURFACE GEOLOGY

OBJECTIVES/DEPTHS: The objective formation is the coal seams of the Ferron Sandstone at about 2200'-2400'
