





2.6.2 The Ferron Coals and lower Ferron Sandstone will be the only gas and water bearing formations. The projected interval of the Ferron is 2060-2210 feet. 5-1/2" 17# WC75 casing will be run and cemented with 250 sacks light cement and tail-in with 100 sacks class "A".

2.6.3 A double gate 3000 psi BOPE will be used with a rotating head. This equipment will be tested to 2100 psi or 70% of the minimum internal yield pressure. All tests will be recorded in a Driller's Report Book. Physical operation of BOP's will be checked on each trip. See Attachment #3 for Schematic.





Gentlemen:

Pursuant to Utah Code Ann. § 40-6-18, (1953, as amended), Utah Admin. R. 649-2-3, Application of Rules to Unit Agreements and R. 649-3-4, Permitting of Wells to be Drilled, Deepened or Plugged-Back, approval to drill the referenced well is hereby granted.

In addition, the following specific actions are necessary to fully comply with this approval:



3. The drillsite is in a big game winter range, therefore, drilling activity should be avoided from December 1, through April 15.
