

2.6.2 The Ferron Coals and lower Ferron Sandstone will be the only gas and water bearing formations. The projected interval of the Ferron Coal is 1860-1960'. 5-1/2" 17# WC75 casing will be run and cemented with 250 sacks light cement and tail-in with 100 sacks class "A".

2.6.3 A double gate 3000 psi BOPE will be used with a rotating head. This equipment will be tested to 2100 psi or 70% of the minimum internal yield pressure. All test will be recorded in a Driller Report Book. Physical operation of BOP's will be checked on each trip. See attachment #3 for Schematic.


SURFACE ELEVATION


COUNTY FARMGROUND

WELL & PIPELINE MAP



Site is located on the north slope of a 100' high ridge running west to east. Shallow gullies running northeast cross site.

LAND USE:

CURRENT SURFACE USE: Livestock grazing. Deer and elk winter habitat.

PROPOSED SURFACE DISTURBANCE: Location is approximately 200' by 250'. Reserve pit and access road.

AFFECTED FLOODPLAINS AND/OR WETLANDS: None. This location would be an active water drainage only in the event of a flash flood.

FLORA/FAUNA: Salt brush, sage, native grasses, shad scale, prickly pear, greasewood. Rabbits, coyotes, reptiles, small indigenous birds, raptors, deer and elk in winter.

ENVIRONMENTAL PARAMETERS

SURFACE GEOLOGY

SOIL TYPE AND CHARACTERISTICS: Silty shale, aluvium, light tan to light gray.

SURFACE FORMATION & CHARACTERISTICS: Weathered Mancos shale, Medium to dark, with occasional seams of siltstone and fine sandstone.

EROSION/SEDIMENTATION/STABILITY: Some erosion, minor sedimentation. No stability problems. Erosion could be a problem if location is not bermed.
