 7.5 MINUTE SERIES MAP.




2.3 This gas well will be drilled approximately 4 ½ miles West of Price, Utah.

2.5 Water will be purchased from Price River Water Improvement District, PRWID. This was previously arranged by Mr. Mike Farrrens of RGC with Mr. Phillip Palmer of PRWID and approved by Mr. Mark Page of the Utah State Division of Water Rights.

2.6 Drilling Program

2.6.2 The Ferron coals and lower Ferron Sandstone will be the only gas and water bearing formations. The projected interval of the Ferron is 2230'-2520' feet. 5 ½" 17#/ft WC75 casing will be run and cemented with 250 sacks 50/50 Pozmix and tail in with 66 sacks RFC.

2.6.3 A double gate 3000 psi BOPE will be used with a rotating head. This equipment will be tested to 2100 psi or 70% of the minimum internal yield pressure. All tests will be recorded in a Driller's Report Book. Physical operation of the BOP's will be checked on each trip. See Attachment "G" for a schematic of the BOPE.





LOCATION LAYOUT





1. Existing Roads

- A. See Exhibit "B"; We do not plan to change, alter or improve upon any existing state or county roads. Existing roads will be maintained in the same or better condition.
- B. From underpass beneath Hwy.6, travel west on Westbrook .6 mile to four-way stop, thence right on Fairground Rd. 0.7 mile, turns into Gordon Creek Rd., follow to three-way stop. Go right (northwest) on Gordon Creek Rd. .3 mile to four-way stop, thence left on Gordon Creek Rd. .5 mile to gravel road on left. Follow gravel road 4.9 miles, thence right on dirt road .3 mile to fork, turn right and travel .3 mile to fork, turn right and travel .3 mile, then right one mile, then south on old two-track 0.1 mile to location.

2. Planned Access

See Exhibit "B" 0.1 mile of new access is required.

- a. Maximum Width: 14' travel surface with 27' base
- b. Maximum grade: 2%
- c. Turnouts: None
- d. Drainage design: Natural drainage will be retained. Water will be diverted around well pad as necessary.
- e. Cuts and fills: None
- f. Surfacing materials: 4" sand and gravel if necessary.
- g. Gates, cattleguards, fence cuts: None

If well is productive, road will be surfaced and maintained as necessary to prevent soil erosion and accommodate year-round traffic.

3. Location of Existing Wells

- a. See Exhibit "B" ; There are no existing wells within one mile of the proposed location.

4. Location of Existing and/or Proposed Facilities

- a. If the well is a producer, installation of production facilities will be as shown on EXHIBIT "E". Buried powerlines run along access on the east and north, gathering lines on the south or west.
- b. Rehabilitation of all pad areas not used for production facilities will be made in accordance with landowner stipulations.

5. Location and Type of Water Supply

- a. Water to be used for drilling will be purchased from the Price River Water Improvement District (PRWID) (tel. 801-637-6350). This has been arranged by Mr. Michael J. Farrens, Executive Vice President of River Gas Corp. He has been in contact with Mr. Phillip Palmer of PRWID. Mr. Farrens has discussed this arrangement with Mark Page of the Division of Water Rights (tel. 801-637-1303) over the telephone. The Division of Water Rights is to furnish the Oil & Gas Division with a letter of approval concerning this matter.
- b. Water will be transported by truck over approved access roads.
- c. No water well is to be drilled for this location.

6. Source of Construction Materials

- a. Any construction materials needed will be obtained locally and hauled to the location on existing roads.
- b. No construction or surfacing materials will be taken from Federal/Indian land.

7. Methods for handling waste disposal

- a. As the well will be air drilled, a small reserve pit will be constructed with a minimum of one-half the total depth below the original ground surface on the lowest point within the pit. The pit will not be lined unless conditions encountered during construction warrant it or if deemed necessary by the DOGM representative during the pre-site inspection. Three sides of the reserve pit will be fenced within 24 hours after completion of construction and the fourth side within 24 hours after drilling operation

cease with four strands of barbed wire, or woven wire topped with barbed wire to a height of not less than four feet. The fence will be kept in good repair while the pit is drying.

b. Following drilling, the liquid waste will be evaporated from the pit and the pit backfilled and returned to natural grade.

No liquid hydrocarbons will be discharged to the reserve pit or location.

c. In the event fluids are produced, any oil will be retained in tankage until sold and any water produced will be retained until its quality can be determined. The quality and quantity of the water will determine the method of disposal.

d. Trash will be contained in a portable metal container and will be hauled from location periodically and disposed of at an approved disposal site. Chemical toilets will be placed on location and sewage will be disposed of at an appropriate disposal site.

8. Ancillary Facilities

a. We anticipate no need for ancillary facilities with the exception of three trailers to be located on the drill site.

9. Wellsite Layout

a. Available topsoil will be removed from the location and stockpiled. If ground frost prevents the segregation and removal of the topsoil material from the less desirable subsoil material, cross-ripping to the depth of the topsoil material may be necessary. Location of mud tanks, reserve and burn pits, and soil stockpiles will be located as shown on the attachments.

b. A blooie pit will be located 150' diagonally from the drill hole. A line will be placed on the surface from the center hole to the burn pit. Burn pit will not be lined, but will be fenced on four sides to protect livestock/wildlife.

c. Access to the well pad will be as shown on Exhibit "G".

d. Natural runoff will be diverted around the well pad.

10. Plans for Restoration of Surface

a. All surface areas not required for producing operations will be graded to as near original condition as possible and contoured to maintain possible erosion to a minimum.

b. Available topsoil will be stockpiled and will be evenly distributed over the disturbed areas and the area will be reseeded as prescribed by the landowner.

- c. Pits and any other area that would present a hazard to wildlife or livestock will be fenced off when the rig is released and removed.
- d. Any oil accumulation on the pit will be removed or overhead flagged as dictated by then existed conditions.
- e. Date of commencement will be July, 1996. Rehabilitation will commence following completion of the well. Rat and mouse holes will be filled immediately upon release of the drilling rig from the location. If the wellsite is to be abandoned, all disturbed areas will be recontoured to the natural contour as is possible.

11. Surface Ownership

- a. The wellsite and access road will be constructed on lands owned by the Telonis family whose representative is Nick Sampinos, attorney, 80 West Main, Suite 201, Price, Utah 84501. The operator shall contact the landowner rep and the Division of Oil, Gas & Mining 48 hours prior to the beginning construction activities.

12. Other Information:

The primary surface use is grazing. The nearest dwelling is ± 1.4 miles northeast of the location. Nearest live water is 1.3 miles north.

If there is snow on the ground when construction begins, it will be removed before the soil is disturbed. And piled downhill from the topsoil stockpile location.

The backslope and foreslope will be constructed no steeper than 4:1.

All equipment and vehicles will be confined to the access road and well pad.

A complete copy of the approved Application for Permit to Drill (APD) including conditions and stipulations, shall be on the wellsite during construction and drilling operations.

There will be no deviation from the proposed drilling and/or workover program without prior approval from the Division of Oil, Gas & Mining.



Geology/Ground Water:

There are no aquifers with high quality ground water expected to be encountered. Garley Canyon Ss. Beds of the Blue Gate Shale Member of the Mancos Shale will be present at this location. If the Garley Canyon Ss. Beds are wet (unlikely, although standing water was found in upper Garley Canyon Ss. Beds in Pinnacle Canyon, ~2.25 miles to southwest), both beds should be included within the proposed surface casing string. The operator is informed of the potential for wet Garley Canyon Beds and will respond to protect the zone by extending the surface casing string as needed to protect the beds with the surface string.
