



2.6.2 The coals within the Ferron Sandstone will be the target gas and water bearing formations at approx. 1310-1410'. 5-1/2" 17# WC75 casing will be run and cemented with approximately 200 sacks 50/50 Pozmix cement and tail-in with 65 sacks "RFC".

2.6.3 A double gate 3000 psi BOPE will be used with a rotating head. This equipment will be tested to 2100 psi or 70% of the minimum internal yield pressure. All tests will be recorded in a Driller's Report Book. Physical operation of BOP's will be checked on each trip. See Attachment #3 for Schematic.



MEMORANDUM OF SURFACE LAND USE AGREEMENT

THIS MEMORANDUM OF SURFACE LAND USE AGREEMENT, dated effective the 27th day of April, 1995, is by and between Arthur Milburn Williams, Trustee of the Arthur Milburn Williams Living Trust, 2211 South Highway 10, Price, UT 84501, Alice E. Jensen, Trustee of the Alice E. Jensen Family Living Trust dated May 8, 1992, 2198 South Highway 10, Price, UT 84501, Russell Waterman, 2266 South Highway 10, Price, UT 84501, Barbara Hunt, 440 West Main Street, Wellington, UT 84524, Mildred Bonnell, 461 South 300 West, Brigham City, UT 84501 and Beatrice Randall, 267 West 2000 South, Price, UT 84501, (hereinafter referred to as "Grantor"), and RIVER GAS CORPORATION, an Alabama corporation authorized to conduct business in the state of Utah, with an address of 511 Energy Center Blvd., Northport, Alabama 35476 (hereinafter referred to as "Grantee").


