






- Point #2 Planned Access Roads - A new road, approximately .90 miles in length, will be constructed, which will be close to bordering BLM surface acreage (see Attachment #4). Planned road dimensions are given on Attachment #6
- Point #3 Wells within 1-mile radius of proposed location - Three producing gas wells operated by River Gas Corporation are located < 1 mile of proposed location (See Attachment #4)
- Point #4 Location of Production Facilities and Pipelines - see Attachment # 4
- Point #6 Source of Construction Material - Other than native Mancos Shale, sand and gravel will be purchased from a local construction company
