



RANGE 9 EAST




**BASIS OF ELEVATION**

No near-surface water is expected to be encountered. 5-1/2" 17# WC75 casing will be run and cemented with approximately 250 sacks 50/50 Pozmix cement and tail-in with 65 sacks "RFC".

2.6.3 A double gate 3000 psi BOPE will be used with a rotating head. This equipment will be tested to 2100 psi or 70% of the minimum internal yield pressure. All tests will be recorded in a Driller's Report Book. Physical operation of BOP's will be checked on each trip. See Attachment #3 for Schematic.

#### **Surface Use Plan**

- Point #2      Planned Access Roads - An existing two-track road, approximately 1/3 mile in length, will be used to reach site (see Attachment #4)
  
- Point #3      Wells within 1-mile radius of proposed location - Two wells, one shut-in gas well and one shut-in water disposal well, are located approximately 1000 yards south of proposed location. (See Attachment #4)
  
- Point #4      Location of Production Facilities and Pipelines - This well will be drilled primarily as a stratigraphic test. No plans exist for pipeline construction at this time.
  
- Point #6      Source of Construction Material - In-place residual of Mancos Shale
  
- Point #7      Waste Management Plan - All drill cuttings will be diverted to pit, as well as fluids encountered. Afterwards, the fluids will be allowed to evaporate and cuttings will be buried. Also, a portable bathroom facility will be provided during drilling operations



**AFFIDAVIT CONCERNING SURFACE OWNER

**JOSEPH L. STEPHENSON**, being first duly sworn upon his oath, deposes and states:

1. I am Vice President - Land of River Gas Corporation ("RGC"), an Alabama corporation duly authorized to transact business in the State of Utah, and am authorized to execute this Affidavit on behalf of said corporation.

2. As Vice President - Land, I am responsible for supervision of lease records and reviewing title records and legal opinions affecting lands where RGC proposes to conduct operations, and obtaining surface land use agreements associated with the development of leased mineral rights.

3. RGC proposes to drill a corehole named the Birkinshaw 19-108 located in the NE1/4 of Section 19, T14S, R9E, S1M, Carbon County, Utah, the surface and mineral of said lands being owned by the estate of Jack T. Birkinshaw, deceased, of which Thelma Ann Jones, also known as Jill T. Jones, is the Personal Representative of said estate in accordance with Letters Testamentary issued in Carbon County, Utah under Probate No. 953700028ES (hereafter called "fee owner").

4. RGC and Texaco Exploration and Production Inc. are the owners of 100% of the working interests to the Oil, Gas and Mineral Lease dated September 1, 1986 recorded in Book 267 at Pages 78-79 of the Office of County Recorder, Carbon County, Utah affecting the above described lands.

5. As evidenced by copy of MEMORANDUM OF SURFACE LAND USE AGREEMENT dated June 1, 1995 attached hereto as Exhibit "A", and by this reference incorporated herein, the above described fee owner of the Birkinshaw 19-108 well site agreed to certain surface use as described therein.

6. The matters stated herein are true of my own knowledge, except to any matters stated herein upon information and belief, and, as to those matters, I believe them to be true.

MEMORANDUM OF SURFACE LAND USE AGREEMENT

THIS MEMORANDUM OF SURFACE LAND USE AGREEMENT, dated effective the 1st day of June, 1995, is by and between Jill T. Jones, General Personal Representative of the Estate of Jack T. Birkinshaw, Deceased, with an address at P. O. Box 7146, Alhambra, CA 91802-7146, (hereinafter referred to as "Grantor"), and RIVER GAS CORPORATION, an Alabama corporation authorized to conduct to business in the state of Utah, with an address of 511 Energy Center Blvd. Northport, Alabama 35476 (hereinafter referred to as "Grantee").

Grantor, in consideration of the covenants and agreements contained in that certain unrecorded Surface Land Use Agreement (the "Agreement") dated June 1, 1995, granted, and does hereby grant unto Grantee certain rights to enter upon and use certain lands (the "Lands") located in the County of Carbon, State of Utah, as described on Exhibit "A" attached hereto and made a part of this Memorandum of Surface Land Use Agreement, for the purpose of building an access road, pipelines and appurtenances thereto, power lines, and a well site for the drilling of a coalbed degasification well on said property until such time as Grantee abandons said land in accordance with the terms and conditions specified in said Agreement.
