
BASIS OF BEARING: South line sec 11








BASIS OF BEARING: South line sec 11



5. The Operator's Minimum Specifications for Pressure Control

EXHIBIT "C" is a schematic diagram of the blowout preventer equipment. A double gate 3000 psi BOPE will be used with a rotating head. This equipment will be tested to 1400 psi. All tests will be recorded in a Driller's Report Book. Physical operation of BOP's will be checked on each trip.

No abnormal pressures or temperatures have been noted or reported in wells drilled in the area nor at the depths

anticipated in this well. Bottom hole pressure expected is 1204 psi maximum.

No hydrogen sulfide or other hazardous gases or fluids have been found, reported or are known to exist at these depths in the area.

8. Anticipated Starting Date and Duration of the Operations.

The well will be drilled in June 1998.

Verbal and/or written notifications listed below shall be submitted in accordance with instructions from the Division of Oil, Gas & Mining:

- (a) prior to beginning construction;
- (b) prior to spudding;
- (c) prior to running any casing or BOP tests;
- (d) prior to plugging the well, for verbal plugging instructions.

Spills, blowouts, fires, leaks, accidents or other unusual occurrences shall be reported to the Division of Oil, Gas & Mining immediately.




EXHIBIT "D"MULTIPOINT SURFACE USE PLAN

## 1. EXISTING ROADS

- A. See Exhibit "E". Existing roads will be maintained in same or better condition.
- B. From fairgrounds travel 2.2 miles on RGC lease road, turn right at intersection, go 1 mile to dead end, turn left and go 1.5 mile to Pinnacle Canyon Rd., then right .4 mile, left onto proposed RGC road 1 mile to east/west proposed RGC road, right 1000' to location on left.

## 2. PLANNED ACCESS

See Exhibit "E". 300' of new access is required.

- A. Maximum Width: 14' travel surface with 27' base
- B. Maximum grade: 4%
- C. Turnouts: None
- D. Surfacing materials: 4" sand and gravel if necessary.
- E. Gates, cattleguards, fence cuts: One fence cut, one cattleguard.

If well is productive, road will be surfaced and maintained as necessary to prevent soil erosion and accommodate year-round traffic.

## 3. LOCATION OF EXISTING WELLS

- A. See Exhibit "E". There is one existing well within one mile of the proposed location, the RGC Prettyman 10-15-34 (shut in) .7 mile west.

mile of the proposed location.

4. LOCATION OF EXISTING AND/OR PROPOSED FACILITIES

- A. If the well is a producer, installation of production facilities will be as shown on EXHIBIT "H". Buried powerlines run along access on the east or north, gathering lines on the south or west.
- B. Rehabilitation of all pad areas not used for production facilities will be made in accordance with landowner stipulations.

5. LOCATION AND TYPE OF WATER SUPPLY

- A. Water to be used for drilling will be purchased from the Price River Water Improvement District (tel. 801-637-6350). This has been arranged by Mr. Michael J. Farrens, Vice President of River Gas Corp. - Utah Operations. He has been in contact with Mr. Phillip Palmer. Mr. Farrens has discussed this arrangement with Mark Page of the Division of Water Rights (tel. 801-637-1303) over the telephone. The Division of Water Rights is to furnish the Oil & Gas Division with a letter of approval concerning this matter.
- B. Water will be transported by truck over approved access roads.
- C. No water well is to be drilled for this location.

6. SOURCE OF CONSTRUCTION MATERIALS

- A. Any construction materials needed will be obtained locally and hauled to the location on existing roads.
- B. No construction or surfacing materials will be taken from Federal/Indian land.

7. METHODS FOR HANDLING WASTE DISPOSAL

- A. As the well will be air drilled, a small reserve pit will be constructed with a minimum of one-half the total depth below the original ground surface on the lowest point within the pit. The pit will not be lined unless conditions encountered during construction warrant it. Three sides of the reserve pit will be fenced within 24 hours after completion of construction and the fourth side within 24 hours after drilling operations cease with four strands of barbed wire, or woven wire topped with barbed wire to a height of not less than four feet. The fence will be kept in good repair while the pit is

drying.

- B. Following drilling, the liquid waste will be evaporated from the pit and the pit backfilled and returned to natural grade.

No liquid hydrocarbons will be discharged to the reserve pit or location.

- C. In the event fluids are produced, any oil will be retained in tankage until sold and any water produced will be retained until its quality can be determined. The quality and quantity of the water will determine the method of disposal.
- D. Trash will be contained in a portable metal container and will be hauled from location periodically and disposed of at an approved disposal site. Chemical toilets will be placed on location and sewage will be disposed of at an appropriate disposal site.

#### 8. ANCILLARY FACILITIES

- A. We anticipate no need for ancillary facilities with the exception of three trailers to be located on the drill site.

#### 9. WELLSITE LAYOUT

- A. Available topsoil will be removed from the location and stockpiled. If ground frost prevents the segregation and removal of the topsoil material from the less desirable subsoil material, cross-ripping to the depth of the topsoil material may be necessary. Location of mud tanks, reserve and burn pits, and soil stockpiles will be located as shown on the attachments.
- B. A blooie pit will be located 150' diagonally from the drill hole. A line will be placed on the surface from the center hole to the burn pit. Burn pit will not be lined, but will be fenced on four sides to protect livestock/wildlife.
- C. Access to the well pad will be as shown on Exhibit "C".
- D. Natural runoff will be diverted around the well pad.

#### 10. PLANS FOR RESTORATION OF SURFACE

- A. All surface areas not required for producing operations will be graded to as near original condition as possible and contoured to maintain possible erosion

to a minimum.

- B. Available topsoil will be stockpiled and will be evenly distributed over the disturbed areas and the area will be reseeded as prescribed by the landowner.
- C. Pits and any other area that would present a hazard to wildlife or livestock will be fenced off when the rig is released and removed.
- D. Any oil accumulation on the pit will be removed or overhead flagged as dictated by then existing conditions.
- E. Date of commencement will be June, 1996, or as soon as possible after APD approval. Rehabilitation will commence following completion of the well. Rat and mouse holes will be filled immediately upon release of the drilling rig from the location. If the wellsite is to be abandoned, all disturbed areas will be recontoured to the natural contour as is possible.

#### 11. SURFACE OWNERSHIP

- A. The wellsite and access road will be constructed on lands owned by James Giacoletto, 3625 West Gordon Creek Rd., Price, UT 84501. The operator shall contact the landowner and the Division of Oil, Gas & Mining 48 hours prior to beginning construction activities.

#### 12. OTHER INFORMATION

The primary surface use is an orchard. The nearest dwelling is ±300' northeast of the location. Nearest live water is 1/4 mile south (Gordon Creek).

If there is snow on the ground when construction begins, it will be removed before the soil is disturbed, and piled downhill from the topsoil stockpile location.

The backslope will be constructed no steeper than 4:1, the foreslope no steeper than 4:1.

All equipment and vehicles will be confined to the access road and well pad.

A complete copy of the approved Application for Permit to Drill (APD) including conditions and stipulations, shall be on the wellsite during construction and drilling operations.

There will be no deviation from the proposed drilling and/or workover program without prior approval from the Division of Oil, Gas & Mining.






## TYPICAL ROAD CROSS-SECTION





## MEMORANDUM OF SURFACE LAND USE AGREEMENT

**THIS MEMORANDUM OF SURFACE LAND USE AGREEMENT**, dated effective the 6th day of March, 1996, is by and between **James Giacoletto, a single person** whose address is 3625 West Gordon Creek Road, Price, Utah 84501, (hereinafter referred to as "**Grantor**"), and **River Gas Corporation**, an Alabama corporation authorized to conduct to business in the state of Utah, with an address of 511 Energy Center Blvd. Northport, Alabama 35476 (hereinafter referred to as "**Grantee**").

Grantor, in consideration of the covenants and agreements contained in that certain unrecorded Surface Land Use Agreement (the "Agreement") dated March 6, 1996, granted, and does hereby grant unto Grantee certain rights to enter upon and use certain lands (the "Lands") located in the County of Carbon, State of Utah, as described on **Exhibit "A"** attached hereto and made a part of this Memorandum of Surface Land Use Agreement, for the purpose of building access roads, pipelines and appurtenances thereto, power lines, and well sites for the drilling of a coalbed degasification wells on said property until such time as Grantee abandons said lands in accordance with the terms and conditions specified in said Agreement.

The Lands are subject to all of the terms and conditions of the Agreement, reference to which may be made for a complete statement of rights and obligations of Grantor and Grantee. Copies of the Agreement may be found at the above indicated addresses of the parties and are available for review during regular business hours by any party having a vested interest in the Agreement.

This Memorandum of Surface Land Use Agreement may be executed in any number of counterparts and shall be binding upon all parties executing the same or a counterpart hereof.

This Memorandum of Surface Land Use Agreement is to be placed of record to serve as notice of the execution and existence of said Agreement, and is in no way to supersede, abrogate, change or modify any of the terms, conditions, rights or obligations of any of the parties, all of which are set forth in detail in said Agreement. The terms and conditions of said Agreement are made a part hereof by reference for all purposes, to be the same effect as though written in extenso herein. All the terms, conditions and covenants of the Agreement shall be binding upon and shall inure to the benefit of the successors and assigns, respectively, of each of the parties hereto.




1-A. A well location approximately two hundred foot (200') by two hundred fifty foot (250') (1.15 acres) in the SE/4 of SW/4, Section 11, T14s-R9e, SLM. (RGC/Giacoletto 11-113 Well).

1-B. A road/pipeline/powerline right-of-way forty foot (40') wide by five hundred foot (500') long (30 rods) (.46 acres) more or less, located in the SE/4 of SW/4 Section 11, T14s-R9e, SLM, which is needed for access to the RGC/Giacoletto 11-113 Well.

1-C. A road/pipeline/powerline right-of-way forty foot (40') wide by two hundred foot (200') long (12 1/2 rods) (.18 acres) more or less, located in the South Center Part of N/2 of NW/4 Section 14, T14s-R9e, SLM, which is needed for crossing of Gordon Creek and access to various wells in the Gordon Creek area.
