FIML Natural Resources, LLC has no objection to the proposed Ute Tribal #14-12-56 well being drilled **1,197' FSL & 1,993' FWL** of Section 12 T-5S R-6W. The original "legal" drillsite location was moved due to severe topographic conditions. Moreover, the Ute Tribal representatives would not allow the drillsite to be placed at the legal location due to the severe topographic constraints.

FIML Natural Resources, LLC is the only owner within a 460 foot radius of the proposed well location.


LOCATION LAYOUT FOR


