2.6.2 The coals within the Ferron Sandstone will be the target gas and water bearing formations at approx. 2290-2390'. 5-1/2" 17# WC75 casing will be run and cemented with approximately 200 sacks 50/50 Pozmix cement and tail-in with 65 sacks "RFC".

2.6.3 A double gate 3000 psi BOPE will be used with a rotating head. This equipment will be tested to 2100 psi or 70% of the minimum internal yield pressure. All tests will be recorded in a Driller's Report Book. Physical operation of BOP's will be checked on each trip. See Attachment #3 for Schematic.







**AFFIDAVIT CONCERNING NOTIFICATION
TO GRAZING PERMITTEE**

JOSEPH L. STEPHENSON, being first duly sworn upon his oath,
deposes and states:

1. I am Vice President - Land of River Gas Corporation ("RGC"), an Alabama corporation duly authorized to transact business in the State of Utah, and am authorized to execute this Affidavit on behalf of said corporation.

2. As Vice President - Land, I am responsible for supervision of lease records and reviewing title records and legal opinions affecting lands where RGC proposes to conduct operations.

3. RGC owns an interest in Oil, Gas and Hydrocarbon Lease ML-43554 on which RGC proposes to drill a coalbed methane gas well named the Utah 16-110, the surface of said lands being owned by the School and Institutional Trust Lands Administration.




RANGE 9 EAST
