We will use Schaffer Blowout preventers - equipped with both blind rams and pipe rams. The preventer will be pressure tested to 500 psi before drilling out after cementing casing surface. Blind rams will be closed each time drill pipe is out of hole, and pipe rams closed daily to meet all safety requirements. Cement between the 4 1/2" casing and hole will be filled to 100' above uppermost hydrocarbon bearing zone. Road work will be coordinated with BLM office in Moab, Utah.
