Schaffer blowout preventers equipped with blind rams and pipe rams will be used. Pipe rams will be fitted to drill in use. Pressure test to 500 psi before drilling out after cementing surface casing. Blind rams will be closed when drill is out of hole and pipe rams will be closed daily to meet all safety requirements. Cement between the 4 1/2" casing and the hole will fill to 100' above the uppermost hydrocarbon zone in the area. All road work and rehabilitation work will be coordinated with BLM office in Moab, Utah.


