This well is plugged to the surface with dirt. The well record for this well is not correct and needs to be changed to reflect the proper footage. The footage information was obtained from the USGS topographic 7.5 minute Quad for Mexican Hat Utah. Updated in 1989.

It is recommended that the wells with no API No. be assigned a number and an appropriate name and that the footage information be updated to match the topographic information. This appears to be a Federal section and the BLM is not interested in Mexican Hat. Therefore little can be done to rectify the lack of proper plugging procedures for these wells. The BLM should be notified, by written notice, that these problems exist.

None of the above wells has proper abandonment markers. It is doubtful that the BLM will pursue this problem to resolution. Therefore once the unassigned wells have been named and numbered, and the BLM notified, the State of Utah will have executed its obligation.

Alternately the State can have well signs made for all of these wells at the State Prison and then post the signs. This can be done for very little expense and would finish clarifying the problem.
