

Dear Mr. McGrath:

The "Surface Use Development Plan" for the proposed McElmo Creek Unit Well #Q-17 is as follows:

1. The existing roads and the location of the main highway exit are shown on the attached USGS topographic map.
2. An existing road runs through the proposed location.
3. The location and status of wells in the vicinity are shown on the attached plat.
4. Lateral roads in the vicinity of the proposed well are shown on the attached plat.
5. The location of existing tank batteries and flow lines are shown on the attached plat. The 2-1/2" flowline for the proposed well will run 1300' easterly to an existing flowline.
6. Water for drilling operations will be obtained from the San Juan River.
7. Waste materials will be collected in earth pits. When drilling operations are complete these earth pits will be backfilled and leveled to the contour of the original landscape.
8. Small portable trailer houses for the Company and contract drilling personnel may be on the location. A sufficient number of OSHA approved chemical toilets will be provided and maintained. No permanent campsites are anticipated.

9. There will be no need for the construction of an airstrip.
10. The location and position of drilling equipment is shown on the attached plat. The drilling pad will be approximately at ground level. Native material from the immediate area will be used.
11. After the well is completed a 75' X 100' production pad will be constructed. All other disturbed areas not necessary to normal well maintenance will be returned, as near as possible, to the original contour that existed prior to the commencement of drilling operations.
12. The proposed drillsite is located on a sandstone outcrop in the foothills above the San Juan. Vegetation consists of sparse desert type ground cover and Tamarisks. Blowout preventer equipment will be a 10" Series 600 with blind rams and drill pipe rams hydraulically and manually controlled. The blowout equipment will be tested at regular intervals.


There are no Indian habitations or artifacts in the immediate vicinity of the proposed drillsite, access road or flowline.






McELMO CREEK UNIT

The production engineers and operations staff at McElmo Creek Unit recommend pumping corrosion inhibited water down five shut in MCU producing wells to minimize tubing and casing corrosion until these wells are pulled for repairs. Three wells (D-14, G-11, Q-17) have hole in tubing, and will be displaced down both tubing and tbg-csg annulus. Two wells (C-13, H-26) have pump or rod issues and will be displaced down tbg-csg annulus only.





2. Pressure test tubing to 1000 psig. Previous test passed. Shallow part indicated.
3. Kill well as necessary. 11.6# may be necessary.
4. POOH with rods and pump, fish as necessary. LD sinker bars. Call Virgil or Nate to inspect rods. Re-run RodStar as needed. Replace or re-run rods per inspection. Leave sinker bars out.
5. Drop a standing valve. Re-pressure test the tubing to confirm pipe integrity.
6. If the pressure test of the tubing passes, go to step 8, running rods and pump.
7. If a tubing pressure test does not pass, additional steps will be developed.
8. RIH with rods & new 2" (use pump in inventory) . Contact Tech Support for rod questions. If pony rods are used to space out, use the following:
 - Polished Rod
 - Full length sucker rod (25 ft)
 - Longest sub
 - Full length sucker rod (25 ft)
 - Second Longest sub
 - Full length sucker rod (25 ft), etc
9. Long stroke pump to test for good pumping action.
10. Leave enough polished rod for operators to correctly space pump as required.
11. Notify the Area Production Supervisor that well is ready to return to production.


