

Dear Mr. McGrath:

The "Surface Use Development Plan" for the proposed McElmo Creek Unit Well #I-19 is as follows:

1. The existing roads and the location of the main highway exit are shown on the attached USGS topographic map.
2. A new 50' X 30' access road is required, as shown on the attached plat. The proposed road will run southeast to the location and will be of compacted sand and gravel with a maximum grade of 3%. The road will be constructed so as to provide for adequate drainage. No major cuts or fills will be necessary.
3. The location and status of wells in the vicinity are shown on the attached plat.
4. The location of existing tank batteries, flow lines and lateral roads in the vicinity of the proposed well are shown on the attached plat. The 2" flow line for the proposed well will run 1500' north to an existing flow line.
5. Water for drilling operations will be obtained from the San Juan River.
6. Materials necessary for the construction of the access road and drilling pad will be obtained directly from the construction site. No access roads for the purpose of hauling materials will be necessary.
7. Waste materials will be collected in earth pits. The perimeter of these pits will be fenced with small mesh wire. When drilling operations are complete these earth pits will be backfilled and leveled to the contour of the original landscape. Small portable trailer houses for the company and contract drilling personnel may be on the location. A sufficient number of OSHA approved chemical toilets will be provided and maintained.

8. No permanent campsites or airstrips are anticipated.
9. The location and position of drilling equipment is shown on the attached plat. Included on this plat is a cross section diagram showing cuts and fills necessary for the construction of the drilling pad. The drilling pad will be located approximately at ground level. Native materials from the immediate area will be used in its construction.
10. The proposed drillsite is located on a sandstone outcrop near the San Juan River. Surface land is owned by the Navajo Tribe and is used primarily for grazing. Vegetation consists of sparse desert type ground cover and Tamarisks. There are no Indian habitations or artifacts in the immediate vicinity of the proposed drillsite, access road or flow line.




Shaffer Double Gate Blow Out Preventer

2. Pressure test tubing to 1000 psig. Prior test failed.
3. Kill well as necessary.
4. POOH with rods. Stand back in derrick. Call Virgil Holly (435) 444-0020, or Nate Dee for rod inspections. On-site consultants should also give a recommendation along with Kevin Foro, if available. Replace or re-run rods per inspection results.
5. Drop a standing valve. Re-pressure test the tubing to confirm there is a leak.
6. ND WH. NU BOPE.
7. Release the TAC @ 5126' KB. Install a packer. Pressure test BOPE.
8. TOOH with tubing. Look for leak. Tubing was new in July, 2007.
9. Call and notify Virgil Holly or Nate Dee for tubing inspection. On-site consultants should also give a recommendation along with Kevin Foro, if available


