

The above well was spudded on August 9, 1961. A 12-1/4" hole was drilled to 167' where 9-5/8" 32.30' H-40 casing was landed and cemented with 110 sacks of regular cement with 2% HA-5 on August 10, 1961. The casing was tested to 700 psi for 1 hr. and a 8-3/4" hole drilled with gas and gasated water to 2530'. An intermediate string of 7" 20# J-55 casing was set at 2530' and cemented with 200 sacks of regular cement on August 18, 1961. After W.O.C. 36 hrs. the casing was tested to 1000 psi for 1 hr. and a 6-1/4" hole drilled with gas and soap to 4723' where the hole was mudded up.

Drilling continued to 6210' where Induction and Sonic logs were run.

Production casing consisting of 193 jts of 4-1/2" 11.6# J-55 casing was run to 6200' and cemented with 200 sacks of salt saturated 50-50 pozmix with 168# of Hal-Ad 9. Cement in place on September 1, 1951. Temp. survey showed cement top at 4850'.

Released rotary rig. Will move in completion unit to complete.

WELL HISTORY

The above well was spudded on August 9, 1961. A 12-1/4" hole was drilled to 167' where 9-5/8" 32.30# H-40 casing was landed and cemented with 110 sacks of regular cement with 2% HA-5 on August 10, 1961. The casing was tested to 700 psi for 1 hr. and an 8-3/4" hole drilled with gas and gaseated water to 2530'.

An intermediate string of 7" 20# J-55 casing was set at 2530' and cemented with 200 sacks of regular cement on August 18, 1961. After W. O. C. 36 hrs., the casing was tested to 1000 psi for 1 hr. and a 6-1/4" hole drilled with gas and soap to 4848' where the hole was mudded up.

Drilling continued to 6210' where Induction and Sonic Logs were run.

Production casing consisting of 193 jts. of 4-1/2" 11.6# J-55 casing was run to 6200' and cemented with 200 sacks of salt-saturated 50-50 posmix with 168# of Hal-Ad 9. Cement in place on September 1, 1961. Temperature survey showed cement top at 4850'.



Spotted 250 gal. 7-1/2% acid across each set of perforations and broke down each set of perfs at 2500 psi. Pulled packer and ran tubing open-ended to 5317'.

Fracced with 3 Allisons. Used 50,000# 20-40 Sand, 40,200 gal. water with 20# salt/bbl., 34# J-101/1000 gal. water and 10 balls. Max. Pressure 4000 psi, Min. 2400 psi, Final 3700 psi. Instant Shut In 1800 psi, 30 min. 1400 psi. Opened well after 4 hours, well unloaded frac water and gauged 1520 MCF while still making 1" stream of salt water.
