
On behalf of El Paso Production Oil and Gas Co I would like to apologize for the well name confusion that has developed over the past few years. Believe me it's not just between the Government agencies and El Paso, we also have had the same problem internally.

Over the years well names get shortened, abbreviated, and in some cases made longer. Unfortunately these revised names become the common name and as you know all information about these wells is reported by the revised name rather than the official name.

Thank you for helping us identify the wells in our system that have gone through this metamorphism. Please find attached a list of these wells. Note that we have divided the wells into three categories: 1) Yellow highlight is used to identify wells that the state needs to change to match El Paso's database. 2) Blue highlight is used to identify wells that El Paso will change to match the state database. 3) Green highlight is used for wells that have an unnecessary extension that both El Paso and the state need to remove.


We have no objection.

I would like to see the Uintah & Ouray Agency, BIA, and the Ute Indian Tribe, Energy & Mineral Resources Department added to the list of those parties that receive advance Exhibits so as to allow us to have research time prior to Hearing dates. We will be able to provide a more informed recommendation to the Oil, Gas and Mining Board. This may be a difficult situation to attain, as it is not always clear where 'on or adjacent' occurs.




