

A joint field examination was made on February 2, 1982, of the above referenced well site locations and proposed access roads. We feel that the surface use and operating plans are adequate with the following revisions and stipulations:

1. Construction and maintenance of roads, rehabilitation of disturbed areas and construction of pipeline routes, shall be in accordance with surface use standards as set forth in the brochure, "Surface Operating Standards for Oil and Gas Exploration".
2. Traveling off access road right-of-ways will not be allowed. The maximum width of access pads (both existing and planned) will be 30 feet total disturbed area. Roads will be crowned and properly maintained. Turn-outs will not be required. Bar ditches will be installed where necessary.
3. The BLM will be notified at least 24 hours prior to any construction.
4. Burn pits will not be constructed. There will be no burning or burying of trash or garbage at the well sites. Refuse must be contained in trash cages and hauled to an approved disposal site.
5. A wire mesh or net type of fence, topped with at least one strand of barbed wire, will be used around the reserve pits.


6. The BLM will be contacted at least 24 hours prior to any rehabilitation activities.
7. The BLM will be contacted for seeding requirements upon abandonment of the access road and/or location.
8. No topsoil will be stockpiled at the following locations due to the lack of topsoil: wells #59-18 and #220-10. However, both of these locations will have the pad ripped to a depth of 6-10 inches upon abandonment.
9. At well #217-23, the top 4 inches of topsoil will be stockpiled between reference corners #1 & 2.
At well #219-15, the top 4-6 inches of topsoil will be stockpiled between reference corners #2 & 3.
At well #60-18, the top 4 inches of topsoil will be stockpiled between reference corners #2 & 3.
At well #206-9, the top 2-4 inches of topsoil will be stockpiled near reference corner #8.
At well #207-4, the top 2-4 inches of topsoil will be stockpiled near reference corners #1 & 8.
At well #200-7, the top 2-4 inches of topsoil will be stockpiled between reference corner #1 & 2. Also, a diversion ditch will be installed to protect the pad from water runoff.
10. The reserve pits at well #220-10 must be lined prior to drilling.

A cultural clearance was conducted by the Archaeological Environmental Research Corporation, and the Belco Development Corporation has complied with their recommendations.

The proposed activities do not jeopardize listed, threatened, or endangered flora, fauna, or their habitats.

5. MINIMUM SPECIFICATIONS FOR PRESSURE CONTROL

The operators minimum specifications for pressure control equipment are as follows: 10", 3000 PSI hydraulic doublegate BOP or equivalent. Pressure tests of BOP to 1000 PSI will be made prior to drilling surface plug and on each trip for bit.

6. TYPE AND CHARACTERISTICS OF THE PROPOSED CIRCULATION MUDS

It is proposed that the hole will be drilled to approximately + 4500' with 3% KCL H₂O as necessary in order to clean the hole. From 4500' to TD it is planned to drill the well with mud. The mud system will be a water based, gel-chemical mud, weighted up to 10.5 ppg as required for gas control.

7. AUXILIARY EQUIPMENT TO BE USED

Auxiliary equipment to be used will be a 2", 2000 PSI choke manifold and kill line, stabbing valve, kelly cock and visual mud monitoring.

8. TESTING, LOGGING AND CORING PROGRAMS

No coring or drill stem testing has been scheduled for this well. Logging will consist of Dll, CNL, FDC w/Caliper & Cyberlook.

9. ANTICIPATED ABNORMAL PRESSURE OR TEMPERATURES

It is not anticipated that abnormal hazards such as high pressures, temperatures or gas will be encountered.

10. ANTICIPATED STARTING DATE AND DURATION OF OPERATIONS

Anticipated starting date is April 15, 1982.
Drilling operations should be complete approximately 4 weeks from the date they commence.

13 POINT SURFACE USE PLAN

1. EXISTING ROADS

- A. The wellsite is located 1366' FSL & 1445' FWL NE/SW Section 4, T10S, R21E, Uintah County, Utah.
Refer to attached plat and Topo Maps "A" and "B". The proposed wellsite is approximately 18 1/2 miles South of Ouray, Utah.
- B. To reach the proposed location, refer to attached Topo Map "A".
- C. The proposed access route is outlined on attached Topo Map "B".
- D. See Topo Map "B".
- E. Not applicable
- F. Access to the wellsite will be over existing county roads and Belco's planned access road.

2. PLANNED ACCESS ROAD

See attached Topo Map "B".

The planned access road is approximately 800' in length and will comply with the general specifications as outlined.

- A. The proposed access road will be a minimum of 16' crown road with ditches along either side of the road where it is determined necessary in order to handle any runoff from normal weather conditions in the area.
- B. Maximum grade of the proposed access road will not exceed 3%.
- C. No turnouts are planned for the length of the proposed access road. Line of sight vision is such that turnouts are not considered necessary.
- D. Drainage design of the proposed access road will avoid unnecessary disturbance of natural runoff patterns. Drainage will be implemented so as not to cause siltation or accumulation of debris.
- E. Surfacing material shall be the native borrow material from the cut areas and will be used to stabilize the road surface and location. No other materials for construction are anticipated.
- F. No fences will be crossed in order to access the proposed location. No cattle guards will be needed.
- G. The proposed road has been centerline flagged for the full distance of the proposed route.

4. LOCATION OF EXISTING AND PROPOSED FACILITIES

- A. Existing production facilities located within one mile of the proposed well are:
1. Tank Batteries - NBU 28-4B, NBU 29-5B, CIGE 38-4-10-21
 2. Production Facilities - Same as above
 3. Oil Gathering Lines - None
 4. Gas Gathering Lines - None

- B. The attached Location Layout plan shows the proposed production facilities that will be utilized in the event that this well produces gas. All production facilities owned and controlled by Belco will be kept of this pad.

Construction materials will be of native borrow or cut exposed on the site and will be consistent with accepted oilfield standards and good engineering practices.

A three strand barbed wire fence will be constructed and maintained in good order around any disposal pits during the drilling and completion phases of this well. When these pits are no longer needed or within 90 days, they will be covered over with native borrow material and rehabilitated to conform with the area.

Guard rails will be constructed around the wellhead to prevent access to livestock or wildlife.

Rehabilitation of the pits is discussed above. The remaining pad not used for producing operations will be recontoured to conform with the natural grade and covered with topsoil saved on the site. The area will be rehabilitated as per BLM specifics.

5. LOCATION AND TYPE OF WATER SUPPLY

- A. Water to be used to drill this well will be hauled by truck from ponds located in the SE/NW of Section 16, T10S, R21E.
- B. Water will be hauled by truck, preferred carrier is Dalbo, PSC #536, on the proposed access route. See Topo Map "B" for access route. No new roads or pipelines will be needed for this purpose.
- C. No water well will be drilled.

6. SOURCE OF CONSTRUCTION MATERIALS

All construction materials for this location site and access road shall be native borrow rock and soil accumulated during the construction of this location. No additional road gravel or additional materials are anticipated at this time.

7. METHODS OF HANDLING WASTE DISPOSAL

- A. Drill cuttings, drilling fluids, salts, chemicals and produced fluids will be disposed of in the reserve pit on the location pad.
- B. fluids will be disposed of in the reserve pit on the location pad.
- C. pad.
- D. A portable toilet will be provided for human waste during the drilling phase of this well.

POINT 7 CONT.....

- E. Garbage and other waste materials will be contained in wire mesh cages and disposed of in an approved waste disposal facility.
- F. Immediately after the drilling rig moves off the location the remaining trash and garbage will be collected and hauled away by truck. The reserve pit will be fenced on the open side to protect domestic animals and wildlife. This pit will be utilized during the completion and testing phase of the well for storage of produced fluids.

8. ANCILLARY FACILITIES

There are no airstrips or camps planned for at the present time.

9. WELL SITE LAYOUT

See attached Location Layout sheet which shows the following items.

- A. Cross section of the pad showing details of the cuts and fills.
- B. Location of the reserve pits, pipe racks, topsoil stockpile and excess cut stockpile.
- C. Rig orientation, parking area, and access road.
- D. Pits will be lined to conserve water and will be fenced on the fourth side at the completion of operations.

10. PLANS FOR RESTORATION OF SURFACE

In the event of a dry hole, pits will be allowed to dry and will then be backfilled and waste pits will be backfilled. The location will be restored to as near the original contour as feasible and then reseeded.

- A. Upon completion of the testing phase of the well, the areas not needed for access to the well and used for producing operations shall be restored as near as possible to the original contour. After final plugging and abandonment of the well, the entire disturbed area will be restored and reseeded as recommended by the Bureau of Land Management.
- B. The revegetation of the drill site area and access not needed to carry on production operations will be reseeded as recommended by the
- C. All pits will be fenced prior to disposal of any waste material and the open side of the reserve pit will be fenced before removing the rig from the location. The fences will be maintained in good condition until item "A" above is started.
- D. Any oil or condensate on any temporary pit will be removed in a timely manner. Overhead flagging or netting will be installed on any sump pit used to handle well fluids during the producing life of the well.
- E. Restoration activities shall begin within 90 days after the completion of the well. Once completion activities have begun they shall be completed within 30 days.

11. OTHER INFORMATION

Topography of the general area is relatively flat rolling terrain consisting of clay and stabilized sand dunes.

Vegetation in the area consists mainly of sagebrush and native grasses.

Wildlife consists of reptiles, small rodents and birds.

Stock grazing and mineral exploration are the only surface use activities in the area.

All lands involved with this location are controlled by the

There is no water in the immediate vicinity of this location. No occupied dwellings or known archeaolofical or cultural sites are in the area of this location.




DIAGRAM "A"






Upon approval of all concerned regulatory agencies, CIG proposes to install a surface flow line from NBU 207-4 in a southeasterly direction through the S/2 of Section 4 connecting to Line F 186-4" in the SE/4 of Section 4, all in 10S-21E. The line will be approximately 1900' long, as shown on the attached sketches.

Pipe will be 4½" O.D. x .125" W.T., Grade X-42 EW. It will be butt-welded in place, using portable electric welding machines, and will be laid aboveground except where burial is necessary for road crossing, ditches, or other obstructions. Magnesium anodes will be installed at the dehydrator, meter setting, road crossings, underground piping at stream crossings, and at producer's separator for corrosion protection.

CIG will connect to producer's separator and install dehydration and metering facilities within 100' of connection.

Some damage will be incurred by trucks transporting pipe and welding equipment over the pipeline route, but surface disturbance will be held to a minimum.


We have no objection.

With further comment to Rulemaking, I wish to comment concerning the provision of Exhibits for upcoming Hearings. I would like to see the Uintah & Ouray Agency, BIA, and the Ute Indian Tribe, Energy & Mineral Resources Department added to the list of those parties that receive advance Exhibits so as to allow us to have research time prior to Hearing dates. We will be able to provide a more informed recommendation to the Oil, Gas and Mining Board. It would be best if we would receive only those Exhibits that concern Indian lands, specifically on or adjacent to Indian lands. This may be a difficult situation to attain, as it is not always clear where 'on or adjacent' occurs.


