

## CONDITIONS OF APPROVAL OF PROJECTS

Re: Belco Development  
Well #237-22 Chapita Wells Unit  
Section 22, T9S, R22E  
Uintah County, Utah

1. Travelling off access road rights-of-way will not be allowed. The maximum width of access roads (both existing and planned) will be 30 feet total disturbed area. Roads will be crowned and properly maintained. Turnouts will not be required. Bar ditches will be installed where necessary.
2. Burn pits will not be constructed. No trash or garbage will be burned or buried at the well sites.
3. A wire mesh or net type of fence, topped with at least one strand of barbed wire, will be maintained around the reserve pits.
4. The BLM will be contacted at least 24 hours prior to any rehabilitation activities. The operator may be informed of any additional needed seeding requirements.
5. Run adequate electric, sonic, radioactivity and caliper logs to identify prime oil shale zones and fresh water aquifers. Casing and cementing programs will be adjusted to protect oil and gas zones, other minerals, and fresh water.
6. Additional stipulations are attached for production facilities.

## ADDITIONAL STIPULATIONS FOR PRODUCTION FACILITIES

Your Application for Permit to Drill also included a submittal for production facilities. These production facilities are approved for the lessee and his designated operator under Section 1 of the Oil and Gas Lease with the following conditions:

- (1) The oil and gas measurement facilities must be installed on the well location. The oil and gas meters will be calibrated in place prior to any deliveries. Tests for meter accuracy are to be conducted monthly for the first three months on new meter installations and at least quarterly thereafter. Please provide this office with a date and time for the initial meter calibration and all future meter proving schedules. A copy of the meter calibration reports are to be submitted to the Salt Lake City District Oil and Gas Supervisor. Royalty payments will be made on all production volume as determined by the meter measurements or the tank measurements. All measurement facilities must conform with the API standards for liquid hydrocarbons and the AGA standard for natural gas measurement.
- (2) Gas meter runs for each well will be located within 500 feet of the wellhead. The gas flowline will be buried from the wellhead to the meter and 500 feet downstream of the meter run or any production facilities. Meter runs must be housed and/or fenced.
- (3) All disturbed areas not required for operations will be rehabilitated.
- (4) All produced liquids must be contained including the dehydrator vent/condensate line effluent. All production pits must be fenced.
- (5) The well activity, the well status and the date the well is placed on production must be reported on Lessee's Monthly Report of Operations, Form 9-329.
- (6) All off-lease storage, off-lease measurement, or commingling on lease or off-lease must have written approval.
- (7) All product lines entering and leaving hydrocarbon storage tanks must be locked/sealed.
- (8) You are reminded of the requirements for handling, storing, or disposing of water produced from oil and gas wells under NTL-2B.
- (9) All materials, trash, junk, debris, etc. not required for production must be removed from the well site and production facility site at the completion of these operations.
- (10) A copy of the Gas Sales Contract will be provided to this office and the Royalty Accounting Department as directed.
- (11) Construction and maintenance for surface use approved under this plan should be in accordance with the surface use standards as set forth in the BLM/GS Oil and Gas Brochure entitled, "Surface Operating Standards for Oil and Gas Exploration and Development." This includes, but is not limited to, such items as road construction and maintenance, handling of top soil and rehabilitation.
- (12) "Sundry Notice and Reports on Wells" (form 9-331) will be filed for all changes of plans and other operations in accordance with 30 CFR 221.58. Emergency approval may be obtained verbally, but such approval does not waive the written report requirement. Any additional construction, reconstruction, or alternations of facilities, including roads, gathering lines, batteries, measurement facilities, etc., will require the filing of a suitable plan and prior approval by the survey.

## General Outline for the Protection and Isolation of Ground Water and Oil Shale in the Uinta Basin.

The oil shale occurs with varying thicknesses in most parts of the Uinta Basin and at varying depths. Ground water also occurs at varied depths above and below the Oil Shale. These ground waters have varying degrees of salinity. Nonetheless, drilling for hydrocarbon in the Uinta Basin should provide for the protection of the oil shale and the ground water if either is present.

The protection of the oil shale and the ground water can effectively be carried on through the design of an adequate casing and cementing program for each well drilled in the area.

In the Uinta Basin, water occurs mainly in the Uinta and the Green River formations. As drilling for hydrocarbon gets deeper into the crust of the earth, more ground water might be encountered and will be protected as it is encountered.

This notice's purpose is to attempt to lay the groundwork for a casing program and cementing program that will protect the oil shale and the ground water if present.

These programs are to be considered as guidelines. The specificity of casing depth, amount of cement and the depth of staging collars will be considered on an individual basis after a careful study of the logs of each individual well. Cementing from the bottom up is an economical solution if carefully conducted.

The casing and cementing program presented here as an example, will assume that fresh water was encountered in the upper parts of the Green River, that the oil shale occurs in the middle of the Green River (1000 foot section) and that some ground water is encountered in the lower parts of the Green River.

In this case, three areas will have to be cemented to assure the integrity of the ground water and oil shale. These areas are above the upper fresh water, across the oil shale and below the lower water aquifer. Deep aquifers that do not contain useful water are cemented to prevent water zone influence on production.

The following casing and cementing program will be appropriate for this example:

- A. Surface casing is set at approximately 300 feet and cemented to the surface.

- B. The next casing string will be set at approximately 300 feet below the lowest aquifer. Cementing will be done in three stages, using two stage collars and cement baskets or equivalent as described below and on attached sketches:
1. Cement first stage through the casing shoe to fill annulus back to base of lower aquifer.
  2. Place 1st stage collar (with cement basket immediately below) at a selected point at the base of the oil shale. Cement will have to reach top of oil shale.
  3. Place 2nd stage collar (with cement basket immediately below) 50 feet above the top of the Bird's Nest aquifer and cement to at least 300 feet above the stage collar.
- C. The above is an example. Reasonable equivalents that accomplish these same protective measures, (such as cementing the water zones instead of isolating them), depending on the individual cases will be considered for approval.
- D. When the above mentioned well is to be abandoned, inner-casing plugs will have to be placed at the same depth as the above mentioned annulus cement jobs.

The use of cement bond logs will verify the authenticity of the cement job performed.

- E. The Operator of such well should notify U.S.G.S. 48 hours prior to commencement of casing and cementing activity, so a technician could be dispatched to witness the operations to verify compliance with casing and cementing program.





Figure 5.- View east of cross section of Uinta Basin showing stratigraphy and intertonguing of Tertiary rocks. Ute Tribal-1 (in section) is located about 8 miles southeast of the application area.





5. MINIMUM SPECIFICATIONS FOR PRESSURE CONTROL

The operators minimum specifications for pressure control equipment are as follows: 10", 3000 PSI hydraulic doublegate BOP or equivalent. Pressure tests of BOP to 1000 PSI will be made prior to drilling surface plug.

6. TYPE AND CHARACTERISTICS OF THE PROPOSED CIRCULATION MUDS

It is proposed that the hole will be drilled to approximately + 4500' with 3% KCL H<sub>2</sub>O as necessary in order to clean the hole. From 4500' to TD it is planned to drill the well with mud. The mud system will be a water based, gel-chemical mud, weighted up to 10.5 ppg if required for gas control.

7. AUXILIARY EQUIPMENT TO BE USED

Auxiliary equipment to be used will be a 2", 2000 PSI choke manifold and kill line, stabbing valve, kelly cock and visual mud monitoring.

8. TESTING, LOGGING AND CORING PROGRAMS

No coring or drill stem testing has been scheduled for this well. Logging will consist of Dll, CNL, FDC w/Caliper & Cyberlook.

9. ANTICIPATED ABNORMAL PRESSURE OR TEMPERATURES

It is not anticipated that abnormal hazards such as high pressures, temperatures or gas will be encountered.

10. ANTICIPATED STARTING DATE AND DURATION OF OPERATIONS

Anticipated starting date is November 15, 1983.

Drilling operations should be complete approximately 4 weeks from the date they commence.

13 POINT SURFACE USE PLAN1. EXISTING ROADS

The proposed wellsite is located 1589' FNL & 280' FWL, SW/NW Section 22, T9S, R22E, Uintah County, Utah. This location is approximately 17.7 miles east of Ouray, Utah. Refer to the attached Topo Maps for directions to the wellsite. Access to the proposed well will be over existing county roads and Belco's planned access road. Traveling will be restricted to these roads only. See attached maps for all roads within this vicinity.

2. PLANNED ACCESS ROAD

See attached Topo Map "B" for details of access road. The access road will be a minimum 18' crown road with ditches along either side where it is determined necessary to handle runoff. Maximum disturbed area will not exceed 24'. There will be no need for turnoffs so the disturbed area can be kept to a minimum. Maximum grade of this proposed access road will not exceed 3%. No fences will be crossed, therefore no cattle guards will be needed. Surfacing material will be of the native borrow from the cut area. No other materials for construction are anticipated at this time.

3. LOCATION OF EXISTING WELLS

See the attached area well map for locations of all wells in this vicinity.

4. LOCATION OF EXISTING AND PROPOSED FACILITIES

Existing production facilities within one mile of the proposed well are the tank batteries and production equipment for the surrounding wells.

The attached diagram "A" shows the proposed production facilities to be utilized should this well produce gas. All production equipment owned and controlled by Belco will be kept of the pad. Production tanks shall be painted a flat, non-reflective, earth tone color that will blend with the environment. Construction materials will be of native borrow or cut exposed on the site and will be consistent with accepted oilfield standards and good engineering practices. A three strand barbed wire fence will be constructed and maintained in good order around the disposal pit during the drilling and completion phases of the well. When these pits are no longer needed or within 90 days, they will be allowed to dry and then covered over with native borrow material and rehabilitated to conform with the surrounding area. Guard rails will be constructed around the wellhead to prevent access to any livestock or wildlife in the area. The remaining pad not needed for producing operations will be recontoured to conform with the natural grade and rehabilitated as per surface owners specifications.

5. LOCATION AND TYPE OF WATER SUPPLY

Water for the drilling of this well will be obtained from the White River at a point near the Mountain Fuel bridge in Section 17, T9S, R22E of Uintah County, Utah. Water will be hauled by truck over existing county roads and Belco's planned access road. No new roads will be needed for this purpose. No pipelines will be needed, no water well drilled. No produced water is anticipated. A permit for use of this water will be obtained from the Ute Tribe prior to starting drilling operations.

6. SOURCE OF CONSTRUCTION MATERIALS

All construction materials for this location and access road will be of native borrow and soil accumulated during the construction of the location. No additional materials are anticipated at this time.

7. METHODS OF HANDLING WASTE DISPOSAL

Drill cuttings, drilling fluids, salts, chemicals and produced fluids will be disposed of in the reserve pit on the location pad. This reserve pit will be fully lined and upon completion of the drilling activities will be fenced on the open side to protect all domestic animals and wildlife. This pit will be utilized during the completion phase of the well for storage of produced fluids. A portable toilet will be provided for human waste during the drilling phase of the well. Garbage and other waste materials will be contained in a wire mesh cage and disposed of in an approved waste disposal facility. After the drilling rig moves off the site, all remaining trash and garbage will be collected and hauled away by truck.

8. ANCILLARY FACILITIES

No airstrips or camps are planned for this well.

9. WELLSITE LAYOUT

The attached Location Layout sheet shows the cross section of the pad with details of cuts and fills. Location of the reserve pit, pipe racks and excess cut stockpile are also shown.

10. PLANS FOR SURFACE RESTORATION

Restoration activities shall commence no later than 90 days after completion of this well. Completion activities shall last no longer than 90 days. All reserve pits will be allowed to dry then backfilled. Any areas not needed for producing operations will be restored to as near their original contour as is feasible. After production activities have ceased, or if abandonment is required, all drainages rerouted during the construction of the well will be restored to their original line of flow. The location pad and access road will be reshaped; stockpiled topsoil will be redistributed over the area and then the entire area will be reseeded with a seed mixture recommended by the surface management agency at a time of the year when the moisture content of the soil is adequate for seed germination.

11. OTHER INFORMATION

The surrounding area is relatively flat with a few stabilized sand dunes in the area. The soil is a light brown sandy clay, 6 to 8" of top soil will be stockpiled to the east & west of the location and will be used after completion for rehabilitation purposes. There is little vegetation in the area, mostly native grasses and sagebrush. The only wildlife apparant is small reptiles, rodents and birds. All land concerned with this project are controlled by the Bureau of Land Management. Livestock grazing, mineral exploration are the only known surface use activities in the area. There are no archeological or cultural sites in the immediate area. There are no occupied dwellings near this wellsite. The White River runs south and west of the proposed wellsite but is over 1 mile away. The Ute Tribe reservation boundry is 280' west of the proposed wellsite.






PRODUCTION FACILITIES SCHEMATIC FOR GAS HOOK-UP





