

Drilling Prognosis

1. Estimated Tops of Important Geologic Markers:

2. Estimated Depths of Anticipated Water, Oil, Gas or Mineral Formations:

Wasatch 4515' Gas (Primary Objective)

If any shallow water zones are encountered, they will be adequately protected and reported; none anticipated. All potentially productive hydrocarbon zones will be cemented off.

3. Pressure Control Equipment:

Type : 10" Double Gate Hydraulic with 1 blind ram (above) and 1 pipe ram (below); equipped with automatic choke and manifold and 9-10" casing head, with Hydril.
Pressure Rating : 3000 psi BOP and 3000 psi choke manifold, 3000 psi casing head, with 3000 psi annular preventer (Hydril).
Testing Procedure : The BOP and choke manifold will be pressure tested to the rated working pressure of 70% of the internal yield strength of the surface casing, whichever is less, for a period of 15 minutes upon installation; once every thirty days and/or when flange seals are broken if a "nipple-up" or "nipple-down" takes place.

Fill line will be 3", kill line will be 3", choke relief line will be 3".
BOP drills and tests will be recorded in the driller's log.

The choke manifold and BOP extension rods with handwheels will be located outside the sub-structure. The hydraulic BOP closing unit will be located at least 25 feet from the well head. Exact locations and configurations will depend upon the particular rig contracted to drill this hole.

Casing string(s) will be pressure tested to 0.2 psi/ft., or 1000 psi, whichever is greater.

B. Cementing Program:

Surface Casing : 120 sx Class "H" w/2% CaCl₂ + 0.25#/sx Celloflake

Production Casing : 800 sx Lite + 1000 sx Class "G" w/2% Gel + 10% Salt.

A greater amount of cement will be used if necessary to ensure that all potentially productive hydrocarbon zones are cemented off. Fill-up to be determined from logs.

Sufficient mud inventory will be maintained on location during drilling to handle any adverse conditions that may arise. Inventory will not be less than the required amount needed to drill this well.

Evaluation program may change at the discretion of the wellsite geologist, with approval of the Bureau of Land Management.

Stimulation : No stimulation or frac treatment has been formulated for this test at this time. The drill site, as approved, will be of sufficient size to accommodate all completion activities.

7. Abnormal Conditions:

No abnormal temperatures or pressure are anticipated. No H₂S gas has been reported or known to exist from previous drilling in the area at this depth. Maximum anticipated bottom hole pressure equals 2000 psi.



B. Auxiliary Equipment:

1. A kelly cock will be kept in the string at all times.
2. Periodic checks will be made each tour of the mud system (refer to Item #5).
3. A stabbing valve will be kept on the derrick floor to be stabbed into the drill pipe whenever the kelly is not in the string.
4. No bit float will be used.
5. A blooie line will be laid from the well head into a separate blooie pit (approximately 25' x 25') during the initial air drilling phase of operations.

Test Procedure

- 1) Flush BOP's and all lines to be tested with water.
- 2) Run test plug on test joint and seat in casing head (leave valve below test plug open to check for leak).
- 3) Test the following to rated pressure:
 - a) inside blowout preventer
 - b) lower kelly cock
 - c) upper kelly cock
 - d) stand pipe valve
 - e) lines to mud pump
 - f) kill line to BOP's
- 4) Close and test pipe rams to rated pressure.
- 5) Close and test Hydril to rated pressure.
- 6) Back off and leave test plug in place. Close and test blind rams to rated pressure.
- 7) Test all choke manifold valves to rated pressure.
- 8) Test kill line valves to rated pressure.

Multi-Point Surface Use and Operations Plan

1. Existing Roads: Refer to Map "B" (Shown in RED)
 - A. The proposed well site is staked and the surveyors plat attached. Two 200-foot reference stakes are present.
 - B. To reach the location from the town of Vernal, Utah; proceed southwest approximately 14 miles on U.S. Highway 40, thence south approximately 7.0 miles on Utah State Highway 209, thence generally south approximately 10.0 miles on Utah State Highway 88 to the town of Ouray, thence generally south approximately 11.5 miles on the Seep Ridge Road (an existing, upgraded county road), thence east approximately 3.8 miles on an existing, upgraded oilfield road, thence north/northwest approximately 1.45 miles on an existing oilfield road, thence generally north approximately 0.95 mile on an existing oilfield road, thence east approximately 0.75 mile to the C.I.G.E. #38 well location, thence northeast approximately 0.45 mile to the proposed location.
 - C. Access roads - refer to Maps "A" and "B".
 - D. Access roads within a one-mile radius - refer to Map "B".
 - E. The existing roads will be maintained in the same or better condition as existed prior to commencement of operations and said maintenance will continue until final abandonment and reclamation of the well location.

2. Planned Access Roads: Refer to Map "A" (Shown in GREEN)

Approximately 0.45 mile of new road construction will be required for access to this location.

 - A. Width - 30-foot right-of-way with 18-foot running surface.
 - B. Maximum grade - 4%.
 - C. Turnouts - none.
 - D. Drainage design - the road will be crowned and ditched with water turnouts installed as required.
 - E. Culverts, cuts and fills - no culverts will be required along the proposed access route. One low-water crossing will be required in a minor drainage along the proposed access road route. There are no major cuts or fills.
 - F. Surfacing material - native materials from construction of access road will be sufficient, no outside construction materials will be required.
 - G. Gates, cattleguards or fence cuts - none required.
 - H. The new access road is flagged.

2. Planned Access Roads: Con't.

- I. The surface lands to be crossed by the proposed access road are owned by the United States of America and are located within the boundary of the Natural Buttes Unit. Therefore, a separate right-of-way application will not be required for access to this location.
- J. All travel will be confined to existing access road rights-of-way.
- K. Access roads and surface disturbing activities will conform to standards outlined in the USGS Publication (1978) Surface Operating Standards for Oil and Gas Development.

4. Location of Existing and/or Proposed Facilities Owned by C.I.G. Exploration, Inc./Coastal Oil & Gas Corporation Within a One-Mile Radius: Con't.

- B. New Facilities Contemplated (Refer to Figure #2)
1. All production facilities will be located on the disturbed portion of the well pad and at a minimum of 25 feet from the toe of the back cut or top of the fill slope.
 2. Production facilities will require an area approximately 300' X 150'.
 3. Production facilities will be accommodated on the well pad. Construction materials needed for installation of the production facilities will be obtained from the site; any additional materials needed will be purchased from a local supplier. A dike will be completely constructed around the production facilities (i.e., production tanks, produced water tanks and/or heater treater). The dikes for the production facilities will be constructed of compacted subsoil, be impervious, hold 1.5 times the storage capacity of the battery, and be independent of the back cut. The integrity of the dike will be maintained.
 4. All permanent above the ground structures will be painted Desert Brown or Carlsbad Canyon (Munsell standard color #'s 10YR6/3 or 2.5Y6/3) within 6 months of installation. The exception being that Utah Occupation Health and Safety Act Rules and Regulations are to be complied with where special safety colors are required.
- C. The production pit will be fenced with mesh wire with one top strand of barbed wire, held in place by side posts and corner 'H' braces in order to protect livestock and wildlife.
- D. During drilling and subsequent operations, all equipment and vehicles will be confined to the access road, well pad and any additional areas specified in the APD.
- E. Reclamation of the disturbed areas no longer needed for operations will be accomplished by grading, leveling and seeding as recommended by the BLM.

5. Location and Type of Water Supply:

- A. Water for drilling will be obtained from an existing water well (Uintah #1) owned by Target Trucking, Inc. and located in the SE $\frac{1}{4}$ SE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 16, T10S, R21E, Uintah County, Utah; Permit #49-991 (A57530).
- B. Water will be hauled over existing roads via tank truck from the point of diversion to the proposed location. No new construction will be required on/along the water haul route. No off-lease/off-unit Federal lands will be crossed on/along the water haul route.

5. Location and Type of Water Supply: Con't.

C. No water well will be drilled on this location.

6. Source of Construction Materials:

- A. No additional construction materials will be needed for well pad construction; surface and sub-surface soils will be sufficient. Refer to Item #2F regarding construction material required on the access road.
- B. The use of materials under BLM jurisdiction will conform to 43 CFR 3610.2-3. Source of construction materials will be located on lease. No construction materials will be taken from Indian lands.
- C. If production is established, any construction materials needed for surfacing access road and installation of production facilities will be purchased from a local supplier.
- D. No new access roads for construction materials will be required.

7. Methods of Handling Waste Material Disposal:

- A. Cuttings - the cuttings will be disposed of in the reserve pit.
- B. Drilling fluids - contained in reserve pit and allowed to evaporate. The reserve pit will be designed to prevent the collection of surface runoff and will be constructed with a minimum of one-half (1/2) the total depth below the original ground surface on the lowest point within the pit.
- C. Produced fluids - hydrocarbons produced during completion operations will be placed in test tanks on the location. Produced waste water will be confined to an unlined pit for a period not to exceed ninety (90) days after initial production. During the ninety (90) day period, an application for approval of a permanent disposal method and location, along with the required water analysis, will be submitted for the District Manager's approval pursuant to Onshore Oil and Gas Order No. 3 (NTL-2B). Any spills of oil, gas, salt water or other noxious fluids will be cleaned up and removed to an approved disposal site.
- D. Sewage - self-contained, chemical toilets will be provided by Rocket Sanitation for human waste disposal. Upon completion of operations, the holding tanks will be pumped and the contents disposed of in a municipal sewage treatment facility or other authorized disposal facility.
- E. Garbage and other waste material - all garbage and inflammable wastes/trash will be contained in a portable trash container and disposed of weekly. No trash will be placed in the reserve pit.

7. Methods of Handling Waste Material Disposal: Con't.

- F. After the rig moves out, all materials will be cleaned up and no adverse materials will be left on the location. Any open pits will be fenced during drilling and kept fenced until such time as the pits are backfilled.
- G. Three sides of the reserve pit will be fenced with wire mesh topped with one top strand of barbed wire before drilling starts. The fourth side will be fenced as soon as drilling is completed. The fence will be constructed as prescribed in the USGS Publication (1978) Surface Operating Standards for Oil and Gas Development. Alternatives to the prescribed standards shall be submitted to the Authorized Officer for approval. Fencing will be maintained until cleanup.
- H. The reserve pit will not be lined, unless fractured rock or porous soils are encountered.

8. Ancillary Facilities:

None

9. Wellsite Layout:

- A. Figure #1 shows the drill site layout as staked. Cross-sections have been drafted to visualize the planned cuts and fills across the location. Approximately four (4) inches of topsoil will be stockpiled for future reclamation of the well site. Refer to Figure #1 for the location of the topsoil stockpile.
- B. Figure #1 is a diagram showing the rig layout. No permanent living facilities are planned. There will be three trailers on location; one each for mud logger, toolpusher, and geologist.
- C. Figure #2 shows the proposed production facilities layout.
- D. The reserve pit will not be lined unless necessary (refer to Item #7H). During the air-drilling phase of operations, a blooie line will be laid from the well head into a separate blooie pit (approximately 25' X 25') constructed at a minimum of 100' from the well head and directly adjacent to the reserve pit.

10. Plans for Reclamation of the Surface:

- A. Backfilling, leveling and re-contouring are planned as soon as the reserve pit dries. Waste and spoil materials will be disposed of immediately upon completion of drilling and workover activities. If production is established, the un-needed areas of the location will be reclaimed as soon as the reserve pit dries. For production, the fill slopes will be reduced from

- A. Con't.
 - a 1.5:1 to a 3:1 slope and the cut slopes will be reduced from a 2:1 to 3:1 slope by pushing the fill material back into the cut.
- B. Upon completion of backfilling, leveling and re-contouring, the stockpiled topsoil will be evenly spread over the reclaimed area(s). All disturbed surfaces (including access road and well pad areas) will be re-seeded using the seed mixture recommended by the BLM. Seed will be drilled on the contour to an approximate depth of 1/2 inch. Fall seeding will be completed after September 1 and prior to ground frost. If applicable, spring seeding will be completed after the frost has left the ground and prior to May 15.
- C. Three sides of the reserve pit will be fenced during drilling and the fourth side will be fenced immediately upon rig removal. Said fencing will consist of woven wire with 1 top strand of barbed wire and corner 'H' braces and will be maintained until leveling and cleanup are accomplished.
- D. If any oil is on the pits and is not immediately removed after operations cease, the pit containing the oil or other adverse substances will be flagged overhead or covered with wire mesh.
- E. The reclamation operations will begin after the drilling rig is removed. Removal of oil or other adverse substances will begin immediately or area will be flagged and fenced. Other cleanup will be done as needed. Planting and re-vegetation is considered best in Fall, 1988, unless requested otherwise.
- F. The following are provisions to be addressed in the restoration of the C.I.G.E. #108D-4-10-21 location.
 - 1. Immediately upon well completion, the location and surrounding area will be cleared of all debris, materials, trash, and junk not required for production.
 - 2. Before any dirt work to restore the location takes place, the reserve pit must be completely dry and all cans, barrels, pipe, etc. will be removed. The reserve pit and that portion of the location and access road not needed for production facilities/operations will be reclaimed. The reserve pit will be reclaimed within 2 years from the date of well completion.
 - 3. All disturbed areas will be re-contoured to the approximate natural contours.
 - 4. The stockpiled topsoil will be evenly distributed over the disturbed areas.
 - 5. Prior to re-seeding, all disturbed areas, including the access roads, will be scarified and left with a rough surface.

10. Plans for Reclamation of the Surface: Con't.

6. Seed will be broadcast or drilled at a time specified by the BLM. If broadcast, a harrow or some other implement will be dragged over the seeded area to assure seed coverage and the seed mixture will be proportionately larger (double the lbs. per acre).
7. An appropriate seed mixture will be determined by the BLM, either as part of the Conditions of Approval of the APD or at the time restoration activities are scheduled to begin.
8. All seeding will be done from September 1 until the ground freezes.
9. At such time as the well is plugged and abandoned the operator will submit a surface reclamation plan to the Surface Management Agency for prescribed seed mixtures and re-seeding requirements.
10. If the seeding is unsuccessful, the lessee/operator may be required to make subsequent seedings.

12. Other Information:

- A. The project area lies within the Natural Buttes Unit in an area characterized by moderately undulated uplands dissected by numerous dendritically-patterned ephemeral drainages. The proposed location is east of Cottonwood Wash, west of the White River, and west of East Bench. Flora consists of bluebunch wheatgrass, Indian ricegrass, cheatgrass, greasewood, four-wing saltbush, winterfat, sagebrush, rabbitbrush, threadleaf sedge, and prickly pear cactus. Fauna consists of mule deer, antelope, coyotes, raptors, rabbits, and various smaller vertebrates.
- B. The primary surface use is for grazing.
- C.
 1. The closest source of permanent water is the White River, located approximately 9.0 miles to the east.
 2. The closest known occupied dwellings are located at Ouray, approximately 12 miles to the northwest.

3. There are no known archeological, historical or cultural sites that will be disturbed by this drilling operation.

In the event cultural resources are observed during construction and operations, they will be left intact and the Area Manager, Bureau of Land Management, Vernal, Utah, will be notified. In addition, if paleontological resources, either large and conspicuous, and/or of significant scientific value are discovered during construction, the find will be reported to the above-authorized officer immediately. Construction will be suspended within 250 feet of said find. 





All lease and/or unit operations will be conducted in such a manner that full compliance is made with applicable laws, regulations (43 CFR 3100), Onshore Oil and Gas Order No. 1, and the approved plan of operations. The operator is fully responsible for the actions of his subcontractors. A copy of these conditions will be furnished the field representative to insure compliance.

A. DRILLING PROGRAM

1. Estimated Depth at Which Oil, Gas, Water, or Other Mineral Bearing Zones are Expected to be Encountered

All fresh water and prospectively valuable minerals (as described by BLM at onsite) encountered during drilling, will be recorded by depth and adequately protected. All oil and gas shows will be tested to determine commercial potential.

Report all water shows and water-bearing sands encountered to Wayne Svejnoha of this office. Copies of State of Utah form OGC-8-X will be acceptable. If noticeable water flows are encountered, submit samples to this office along with any water analyses conducted by the operator.

Ensure that any fresh water is protected by the cement behind the 5½" casing.

2. Pressure Control Equipment

All BOPE and testing procedures will be consistent with API RP 53. Pressure tests will be conducted before drilling out from under all casing strings which are set and cemented in place. Blowout preventer controls will be installed prior to drilling the surface casing plug and will remain in use until the well is completed or abandoned. Preventers will be inspected and operated at least daily to ensure good mechanical working order, and this inspection recorded on the daily drilling report. Preventers will be pressure tested before drilling casing cement plugs.

The District Office shall be notified, with sufficient lead time, in order to have a BLM representative on location during pressure testing.

3. Casing Program and Auxiliary Equipment

The District Office shall be notified, with sufficient lead time, in order to have a BLM representative on location while running all casing strings and cementing.

Ensure that the oil shale in the Mahogany Zone (estimated top at +2,110') is covered by the cement behind the 5½" casing.

4. Mud Program and Circulating Medium

No chromate additives will be used in the mud system on Federal and Indian lands without prior BLM approval to ensure adequate protection of fresh water aquifers.

5. Coring, Logging and Testing Program

Daily drilling and completion progress reports shall be submitted to this office on a weekly basis.

Cement bond log shall be run after cementing the 5½" casing.

Whether the well is completed as a dry hole or as a producer, "Well Completion and Recompletion Report and Log" (Form 3160-4) will be submitted not later than 30 days after completion of the well or after completion of operations being performed, in accordance with 43 CFR 3164. Two copies of all logs, core descriptions, core analyses, well-test data, geologic summaries, sample description, and all other surveys or data obtained and compiled during the drilling, workover, and/or completion operations, will be filed with Form 3160-4. Samples (cuttings, fluids, and/or gases) will be submitted when requested by the authorized officer (AO).

6. Notifications of Operations

No location will be constructed or moved, no well will be plugged, and no drilling or workover equipment will be removed from a well to be placed in a suspended status without prior approval of the AO. If operations are to be suspended, prior approval of the AO will be obtained and notification given before resumption of operations.

The spud date will be reported orally to the AO within 48 hours after spudding. If the spudding occurs on a weekend or holiday, the report will be submitted on the following regular work day. The oral report will be followed up with a Sundry Notice.

In accordance with Onshore Oil and Gas Order No. 1, this well will be reported on Form 3160-6 "Monthly Report of Operations", starting with the month in which operations commence and continue each month until the well is physically plugged and abandoned. This report

will be filed, in duplicate, to the Vernal BLM District Office, 170 South 500 East, Vernal, Utah 84078.

Immediate Report: Spills, blowouts, fires, leaks, accidents, or any other unusual occurrences shall be promptly reported in accordance with the requirements of NTL-3A or its revision.

If a replacement rig is contemplated for completion operations, a "Sundry Notice" (Form 3160-5) to that effect will be filed, for prior approval of the AO, and all conditions of this approved plan are applicable during all operations conducted with the replacement rig.

Should the well be successfully completed for production, the AO will be notified when the well is placed in a producing status. Such notification will be sent by telegram or other written communication, not later than 5 days following the date on which the well is placed on production.

Pursuant to NTL-2B, with the approval of a District Engineer, produced water may be temporarily disposed of into unlined pits for a period of up to 90 days. During the period so authorized, an application for approval of the permanent disposal method, along with the required water analysis and other information, must be submitted to the District Engineer.

Pursuant to NTL-4A, lessees or operators are authorized to vent/flare gas during initial well evaluation tests, not exceeding a period of 30 days or the production of 50 MMCF of gas, whichever occurs first. An application must be filed with the District Engineer and approval received, for any venting/flaring of gas beyond the initial 30 day or authorized test period.

A schematic facilities diagram as required by 43 CFR 3162.7-2, 3162.7-3, and 3162.7-4 shall be submitted to the appropriate District Office within 30 days of installation or first production, whichever occurs first. All site security regulations as specified in 43 CFR 3162.7 shall be adhered to. All product lines entering and leaving hydrocarbon storage tanks will be effectively sealed in accordance with 43 CFR 3162.7-4.

A first production conference will be scheduled within 15 days after receipt of the first production notice.

No well abandonment operations will be commenced without the prior approval of the AO. In the case of newly drilled dry holes or failures, and in emergency situations, oral approval will be obtained from the AO. A "Subsequent Report of Abandonment" Form 3160-5, will be filed with the AO within 30 days following completion of the well for abandonment. Multipoint Requirements to Accompany APD

1. Planned Access Roads

Access roads and surface disturbing activities will conform to standards outlined in the USGS Publication (1978) Surface Operating Standards for Oil and Gas Development.

The road shall be upgraded to meet the standards of the anticipated traffic flow and all-weather road requirements. Upgrading shall include ditching, draining, graveling, crowning, and capping the roadbed as necessary to provide a well constructed safe road. Prior to upgrading, the road shall be cleared of any snow cover and allowed to dry completely. Traveling off the 30 foot right-of-way will not be allowed. Road drainage crossings shall be of the typical dry creek drainage crossing type. Crossings shall be designed so they will not cause siltation or accumulation of debris in the drainage crossing nor shall the drainages be blocked by the roadbed. Erosion of drainage ditches by runoff water shall be prevented by diverting water off at frequent intervals by means of cutouts. Upgrading shall not be allowed during muddy conditions. Should mud holes develop, they shall be filled in and detours around them avoided.

2. Methods for Handling Waste Disposal

Burning will not be allowed. All trash must be contained in a trash cage and hauled away to an approved disposal site at the completion of the drilling activities.

The reserve pit shall not be lined unless fractured rock or porous soils are encountered.

Produced waste water will be confined to an unlined pit or, if deemed necessary, a storage tank for a period not to exceed 90 days after first production. During the 90-day period an application for approval of a permanent disposal method and location, along with required water analysis, will be submitted for the AO's approval. Failure to file an application within the time allowed will be considered an incident of noncompliance.

3. Well Site Layout

All pits will be fenced with a wire mesh fence and topped with at least one strand of barbed wire. The reserve pit fencing will be on three sides during drilling operations and on the fourth side when the rig moves off the location. Any hydrocarbons on the pit will be removed from the pit as soon as possible after drilling operations are completed. Pits will be fenced and maintained until clean-up.

The fence will be constructed as prescribed in the USGS Publication (1978) Surface Operating Standards for Oil and Gas Development.

Alternatives to the prescribed standards shall be submitted to the Authorized Officer for approval.

Well Site Layout: The reserve pit will be located on the east side of the location. A blooie pit will be constructed adjacent to the reserve pit as indicated in the layout diagram.

The stockpiled topsoil will be stored near stake No. 6.

Access to the well pad will be from the south side of the pad.

4. Plans for Restoration of Surface

Immediately upon well completion, the location and surrounding area will be cleared of all debris, materials, trash and junk not required for production.

Before any dirt work to restore the location takes place, the reserve pit must be completely dry and all cans, barrels, pipe, etc. will be removed. The reserve pit and that portion of the location and access road not needed for production facilities/operations will be reclaimed. The reserve pit will be reclaimed within one year from the date of well completion.

5. Other Additional Information

On BLM administered land, it is required that a proposed use of pesticide, herbicide or other possible hazardous chemicals shall be cleared for use prior to application.

The operator or his contractor shall contact the BLM Offices at (801) 789-1362 between 24 and 48 hours prior to construction activities. Contact the Bookcliffs Resource Area.

The area is in pronghorn habitat. Construction and drilling may be restricted during the period May 15 to June 20 for antelope kidding season.

All lease and/or unit operations will be conducted in such a manner that full compliance is made with all applicable laws, regulations, Onshore Oil and Gas Orders, the approved plan of operations, and any applicable Notice to Lessees. The operator is fully responsible for the actions of his subcontractors. A copy of these conditions will be furnished the field representative to insure compliance.

The dirt contractor will be provided with an approved copy of the Surface Use Plan from the APD.

This drilling permit will be valid for a period of one year from the date of approval. After permit termination, a new application will be filed for approval for any future operations.


We have no objection.

With further comment to Rulemaking, I wish to comment concerning the provision of Exhibits for upcoming Hearings. I would like to see the Uintah & Ouray Agency, BIA, and the Ute Indian Tribe, Energy & Mineral Resources Department added to the list of those parties that receive advance Exhibits so as to allow us to have research time prior to Hearing dates. We will be able to provide a more informed recommendation to the Oil, Gas and Mining Board. It would be best if we would receive only those Exhibits that concern Indian lands, specifically on or adjacent to Indian lands. This may be a difficult situation to attain, as it is not always clear where 'on or adjacent' occurs.





The variance is requested as an economic analysis shows the value of the shrunk condensate will not payout the incremental cost of purchasing and maintaining the valve resulting in a loss of value over the producing life of the well.

The volume lost to shrinkage by dropping the tank pressure from 6 ozs. to 0 psig is shown to be 0.3% of the tank volume. This was determined by lab analysis of a representative sample from the field. The sample shrunk from 98.82% of original volume to 98.52% when the pressure was dropped. The average NBU well produces approximately 6 bbls condensate per month. The resulting shrinkage would amount to 0.56 bbls per month lost volume due to shrinkage. The value of the shrunk and lost condensate does not recoup or payout the cost of installing and maintaining the valves and other devices that hold the positive tank pressure. An economic run based on the loss and costs is attached. Westport Oil & gas requests approval of this variance in order to increase the value of the well to the operator and the mineral royalty owners.


