




Supplement to Application for Permit to Drill

1. Location and Type of Water Supply:

- A. Water for drilling will be obtained from an existing industrial water well (Uintah #1) owned by Target Trucking, Inc. and located in the SE $\frac{1}{4}$ SE $\frac{1}{4}$ NE $\frac{1}{4}$ Section 16, Township 10 South, Range 21 East, Uintah County, Utah; Permit Number 49-991 (A57530).

2. Methods of Handling Waste Disposal:

- A. Sewage - self-contained, chemical toilets will be provided for human waste disposal. Upon completion of operations, the holding tanks will be pumped and the contents disposed of in a municipal sewage treatment facility or other authorized disposal facility.
- B. Garbage and other waste materials - all trash will be contained in a portable trash cage. Upon completion of operations, all trash will be hauled to an approved sanitary landfill.
- C. Cuttings and drilling fluids - the cuttings will be deposited in the reserve pit. Drilling fluids will be contained in reserve pit and allowed to evaporate. The reserve pit will be designed to prevent the collection of surface runoff and will be constructed with a minimum of one-half (1/2) the total depth below the original ground surface on the lowest point within the pit. The reserve pit will not be lined unless fractured rock or extremely porous soil/rock formations are encountered.

3. Plans for Reclamation of the Surface:

- A. Backfilling, leveling and re-contouring are planned as soon as the reserve pit dries. Waste and spoil materials will be disposed of immediately upon completion of drilling and workover activities. If production is established, the unneeded areas of the location will be reclaimed as soon as the reserve pit dries.
- B. Upon completion of backfilling, leveling and re-contouring, the stockpiled topsoil will be evenly spread over the reclaimed area(s). All disturbed surfaces (including access road and well pad areas) will be reseeded using the seed mixture recommended by the State of Utah. Seed will be drilled on the contour to an approximate depth of 1/2 inch.
- C. Three sides of the reserve pit will be fenced during drilling operations. Prior to rig release, the reserve pit will be fenced on the fourth side to prevent livestock and wildlife from becoming entrapped, and the fencing will be maintained until leveling and cleanup are accomplished.

3. Plans for Reclamation of the Surface: Continued

- D. If any oil is on the pits and is not immediately removed after operations cease, the pit containing the oil or other adverse substances will be flagged overhead or covered with wire mesh.
- E. The reclamation operations will begin after the drilling rig is removed. Removal of oil or other adverse substances will begin immediately or area will be flagged and fenced. Other cleanup will be done as needed. Rehabilitation operations should be completed by the Fall of 1991.



LOCATION LAYOUT FOR





TYP. LOCATION LAYOUT





7. This approval shall expire one (1) year after date of issuance unless substantial and continuous operation is underway or an application for an extension is made prior to the approval expiration date.



We have been advised of changes occurring with the operation of your database for Change of Operator. You will be modifying your records to reflect Change of Operator once you have received all necessary documentation from the companies involved, and perhaps in advance of our Notice of Concurrence/Approval of Change of Operator where Indian leases are involved.

We have no objection.

With further comment to Rulemaking, I wish to comment concerning the provision of Exhibits for upcoming Hearings. I would like to see the Uintah & Ouray Agency, BIA, and the Ute Indian Tribe, Energy & Mineral Resources Department added to the list of those parties that receive advance Exhibits so as to allow us to have research time prior to Hearing dates. We will be able to provide a more informed recommendation to the Oil, Gas and Mining Board. It would be best if we would receive only those Exhibits that concern Indian lands, specifically on or adjacent to Indian lands. This may be a difficult situation to attain, as it is not always clear where 'on or adjacent' occurs.

I am aware that you have gone to extra effort to correct this matter already, and I fully appreciate it. My request is intended only to allow the addition of Uintah & Ouray Agency and Ute Indian Tribe to the official listing.

We appreciate your concern, and hope that these comments are timely enough for consideration in the revision process.





Westport Oil & Gas requests a variance to Onshore Order No. 4, Part IIIC.a. requiring each sales tank be equipped with a pressure-vacuum thief hatch and/or vent line valve. The variance is requested as an economic analysis shows the value of the shrunk condensate will not payout the incremental cost of purchasing and maintaining the valve resulting in a loss of value over the producing life of the well.

The volume lost to shrinkage by dropping the tank pressure from 6 ozs. to 0 psig is shown to be 0.3% of the tank volume. This was determined by lab analysis of a representative sample from the field. The sample shrunk from 98.82% of original volume to 98.52% when the pressure was dropped. The average NBU well produces approximately 6 bbls condensate per month. The resulting shrinkage would amount to 0.56 bbls per month lost volume due to shrinkage. The value of the shrunk and lost condensate does not recoup or payout the cost of installing and maintaining the valves and other devices that hold the positive tank pressure. An economic run based on the loss and costs is attached. Westport Oil & gas requests approval of this variance in order to increase the value of the well to the operator and the mineral royalty owners.


