

BASIS OF ELEVATION





LOCATION LAYOUT FOR




Figure 4-22 Closed Loop Solids System: Unweighted Fluid



Approved changes will be provided in writing from the Ute Tribe.

A Tribal Technician is to routinely monitor construction. At well pad of well 34-109 a qualified archaeologist is to monitor the construction accompanied by Tribal Technician.

Cattleguards, culverts and diversion ditches or berms are to be constructed where needed.

Road base fill will be stored on location. Where fill is required a minimum of 6 inches depth of road base fill will be used.

Coastal will assure the Ute Tribe that any/all contractors and subcontractors have acquired a current 2000 Tribal Business License and have access permits prior to construction. They will have these permits in vehicles at all times.

Coastal will implement "Safety and Emergency Plan" and Coastal will ensure its compliance.

Coastal employees and/or authorized personnel (subcontractors) in the field will have applicable APD's and/or ROW permits/authorizations on their person(s) during all phases of construction.

All vehicular traffic, personnel movement, construction, and restoration activities shall be confined to the areas examined, as referenced in report, and to the existing roadways and/or evaluated access routes.

All personnel should refrain from collecting artifacts, any paleontological fossils, and from disturbing any significant cultural resources in the area.

The Ute Tribe Energy & Mineral Department shall be consulted if cultural remains (including paleontology fossils) from subsurface deposits are exposed or identified during construction or if the need arises to relocate or otherwise alter the location of the construction area. Prior to commencing constructing in the area where cultural resources are exposed the operator must obtain authorization from the BIA and the Ute Tribal Department of Cultural Rights and Protection.

Upon completion of the project approved under this Application for Permit to Drill and Right-of-way, the Ute Tribe Energy & Minerals Resources Department will be notified by Coastal Oil and Gas Company so that a Tribal Technician can verify Affidavit of Completion's.

Before the site is abandoned, the company will be required to restore the well site and ROWs to near their original state. The disturbed areas will be reseeded with desirable perennial vegetation.

Noxious weeds will be controlled on the well site and rights-of-way. If noxious weeds spread from the project area onto adjoining land, the company will also be responsible for their control.

Coastal shall adhere to the following policy regarding tree removal: avoid tree removal where possible, if tree/trees must be removed then plant four for every one removed in order to mitigate impacts to raptor habitat. A bird survey will be conducted every year to study the raptor habitat.

Soil erosion will be mitigated by reseeding all disturbed areas.

Reserve pits will be lined with impervious synthetic liners. Prior to backfilling the reserve pit all fluids will be pumped from the pit into trucks and hauled to approved disposal sites. When the pits are backfilled, the surplus oil and mud etc. will be buried a minimum depth of 3.0 feet below the surface of the soil.

A closed production system will be used. Production fluids will be contained in leak proof tanks. Low profile tanks may be used to minimize problems with irrigation systems. All production fluids will be disposed of at approved disposal sites. Production water, oil, and other by-products will not be applied to roads or well pads for the control of dust or weeds. The indiscriminate dumping of production fluids on roads, well sites or other areas will not be allowed on Tribal Lands.

Access roads are generally allocated a 30 foot width in the corridor. The access road shall have constructed travel width limited to 18 feet, except as granted for sharp curves or for intersections or for where deep cuts are required for road construction. Culverts will be installed or extended where required and diversion ditches will be placed as needed to improve the proposed roads.

There will be no surface pipelines.

Pipelines will parallel roads and not cross country between stations. The line shall either be welded in place at a welding station located at the wellsite or on roads near the flowline right of way and then dragged into place with a suitable piece of equipment.

Buried flowlines shall be a minimum of three feet below the surface. After the construction of the pipeline is completed the disturbed area of the ROW shall be contoured to blend into the natural landscape, and it shall be reseeded with desirable vegetation. Between September 15 and November 1 of the year following pipeline construction of the buried line all disturbed areas shall be reseeded with perennial vegetation according to BIA, or to Ute Tribe specifications.

Threatened and Endangered species have been identified associated with this project. Stipulations have been developed for their protection. (Remarks from Section 10.0 of the Site Specific Environmental Assessment)

The following shall be strictly adhered to:

-Downhole drilling procedures approved by the Bureau of Land Management.

- Construction activities will be monitored by the Tribal Technicians and BIA.
- No drilling or construction will occur in the 100 year floodplain during seasonal high water conditions.
- The operator will design and construct well pads and roads so as not to impede surface water flow or interfere with fish movements during high water seasons. Locations shall have drainage designed and installed to allow for natural flow movement of receding floodwaters. Tundra pad and gravel base will be installed across floodplain areas for well pads and well locations and removed prior to seasonal high water conditions.
- All buried pipelines which cross floodplain habitat will be periodically pressure tested to ensure that they are free of leaks and are in good condition.
- Should the river channel move within 100 feet of the well head, the well shall be shut-in and plugged immediately unless geologic or hydro-morphology survey determines that the well head is not of risk of damage from the river.
- Quarterly gas production sampling shall be conducted and reported.
- Floodplain wells shall have a dual pipeline system consisting of a flow line and a pressure relief line. Installation is limited to a one time excavation.
- All central tank batteries must be constructed outside of the floodplain.
- A closed loop drilling system must be used.
- Well pads and roads will be built and maintained at natural ground level.
- Above ground well heads will be elevated, and equipped so as to be able to use telemetry to control flow and shut down of production in emergency situations.
- There will be routine monitoring of soil and water quality for contamination.




We have been advised of changes occurring with the operation of your database for Change of Operator. You will be modifying your records to reflect Change of Operator once you have received all necessary documentation from the companies involved, and perhaps in advance of our Notice of Concurrence/Approval of Change of Operator where Indian leases are involved.

We have no objection.

With further comment to Rulemaking, I wish to comment concerning the provision of Exhibits for upcoming Hearings. I would like to see the Uintah & Ouray Agency, BIA, and the Ute Indian Tribe, Energy & Mineral Resources Department added to the list of those parties that receive advance Exhibits so as to allow us to have research time prior to Hearing dates. We will be able to provide a more informed recommendation to the Oil, Gas and Mining Board. It would be best if we would receive only those Exhibits that concern Indian lands, specifically on or adjacent to Indian lands. This may be a difficult situation to attain, as it is not always clear where 'on or adjacent' occurs.

I am aware that you have gone to extra effort to correct this matter already, and I fully appreciate it. My request is intended only to allow the addition of Uintah & Ouray Agency and Ute Indian Tribe to the official listing.

We appreciate your concern, and hope that these comments are timely enough for consideration in the revision process.





Westport Oil & Gas requests a variance to Onshore Order No. 4, Part III C. a. requiring each sales tank be equipped with a pressure- vacuum thief hatch and/or vent line valve. The variance is requested as an economic analysis shows the value of the shrunk condensate will not payout the incremental cost of purchasing and maintaining the valve resulting in a loss of value over the producing life of the well.

The volume lost to shrinkage by dropping the tank pressure from 6 ozs. To 0 psig is shown to be 0.3% of the tank volume. This was determined by lab analysis of a representative sample from the field. The sample shrunk from 98.82% of original volume to 98.52% when the pressure was dropped. The average well produces approximately 6 bbls condensate per month. The resulting shrinkage would amount to 0.56 bbls per month lost volume due to shrinkage. The value of the shrunk and lost condensate does not recoup or payout the cost of installing and maintaining the valves and other devices that hold the positive tank pressure. An economic run based on the loss and costs is attached. Westport Oil & Gas requests approval of this variance in order to increase the value of the well to the operator and the mineral royalty owners.






