




PHOTO: VIEW FROM CORNER #5 TO LOCATION STAKE




PHOTO: VIEW FROM BEGINNING OF PROPOSED ACCESS


LOCATION LAYOUT FOR





TYPICAL CROSS SECTIONS FOR
