

SURVEYOR'S STATEMENT



Dolinar, Professional Land Surveyor, UT PLS #7200155-2201 hereby certify that (in accordance with a request from Crescent Point Energy) personnel under my direction made a survey on the 16th day of September 2014, for the Location and Elevation of platted surface hole being located within the SW1/4 of the SE1/4 and location of bottom hole being located within the SE1/4 of the SW1/4 of Section 19, T7S, R20E of the Salt Lake Meridian, Uintah County, Utah of shown Knop Fed 14-19-7-20E being staked on the ground as shown hereon. Elevation of ungraded ground is 4835.6 ft.

1. Basis of Datum is the Utah State Plane Coordinate System, Central Zone, NAD83 from GPS observations derived from OPUS observations
2. Vertical Datum used is NAVD 88.
3. The Basis of Bearings for this survey is referenced to the South line of the shown SW1/4 of the SE1/4 of Section 19 monumented as shown and bearing S 89°24'13" W.
