This matter came on for hearing before the Board of Oil, Gas and Mining on Wednesday, October 2, 1991, at the request of the Board. The following Board members were present:

Board member, Jay L. Christensen, recused himself. Thomas A. Mitchell, Esq., Assistant Attorney General and Counsel to the Board was present and participating. Also present and representing the Division were Dr. Dianne R. Nielson, Director; Ronald J. Firth, Associate Director for Oil and Gas; Frank R. Matthews, Petroleum Engineer; and Brad G. Hill, Petroleum Geologist. Attending and participating on behalf of the Bureau of Land Management were Robert Henricks, Chief, Branch of Fluid Minerals; and Assad Rafoul, Petroleum Engineer with the Utah State Office; and A. Lynn Jackson, Petroleum Engineer in the Moab District Office. No other parties appeared or participated in the hearing.

Based upon the testimony and evidence presented at the hearing, the Board makes and enters the following Findings of Fact:

FINDINGS OF FACT

1. Due and proper notice was given to all interested parties, and the Board has jurisdiction to hear this matter and to make the findings and order set forth herein.

2. On March 27, 1989, the Board entered its Order in Cause No. 131-81, establishing 640-acre drilling units for the production of gas, oil and associated hydrocarbons from the Upper Green River Formation underlying the following lands in the Bluebell/Altamont Field:

Township 1 South, Range 2 West, USM

Sections 1 and 2:	All
Section 3:	All, except N $\frac{1}{2}$ NW $\frac{1}{4}$
Section 4:	All
Section 9 through 12:	All

The Board further ordered that the permitted well for each drilling unit should be no closer than 660 feet from any quarter section boundary and not less than 3960 feet from any existing well completed in the Upper Green River Formation, with a variance of up to 150 feet for topographic purposes without prior approval, or otherwise as may be permitted by administrative action for topographic or geological reasons without the necessity of a formal Board hearing.

3. On August 1, 1991, the Board entered its Order in Cause No. 131-101-S, establishing 640 acre drilling and spacing units for the production of gas, oil and related hydrocarbons from the

Upper Green River Formation from the following described lands:

Township 1 North, Range 1 West, USM

Section 31: All

Township 1 North, Range 2 West, USM

Sections 31 through 36: All

Township 1 South, Range 1 West, USM

Sections 6 and 7, 18 and 19: All

Township 1 South, Range 2 West, USM

Sections 5 through 8, and 13 through 24: All

The Board further ordered that the permitted well for each drilling and spacing unit should be no closer than 660 feet from any quarter section boundary and not less than 2640 feet from an existing well completed in the Upper Green River formation, with a variance of up to 150 feet for topographic purposes without any hearing or administrative action, or otherwise as may be permitted by administrative action for topographic or geologic reasons.

4. To achieve uniformity for the Board's Orders in Cause No. 131-81 and Cause No. 131-101-S, the Order in Cause No. 131-81 should be modified to substitute "2640 feet" for "3960 feet" in subsection 2 of said Order.

ORDER

Now, therefore, the Board enters the following Order:

1. Modifying its Order in Cause No. 131-81 to substitute "2640 feet" for "3960 feet" in paragraph 2 of said Order.

2. Designating that such modification should apply to the established drilling units for the production of gas, oil and related hydrocarbons from the Upper Green River Formation for the following lands:

Township 1 South, Range 2 West, USM


Section 1 and 2:	All
Section 3:	All except N $\frac{1}{2}$ NW $\frac{1}{4}$
Section 4:	All
Section 9 through 12:	All

3. Designating that such action will achieve uniformity for the Board's Orders in Cause No. 131-81 and Cause No. 131-101-S.

4. That the Board retains continuing jurisdiction over the matters covered by this Order, and over all parties affected thereby.


