**FINDINGS OF FACT,
CONCLUSIONS OF LAW AND
ORDER**

This Cause came on for hearing before the Utah Board of Oil, Gas and Mining (the "Board") on Wednesday, October 22, 2014, at approximately 9:50 a.m., in the Auditorium of the Utah Department of Natural Resources Building in Salt Lake City. The following Board members were present and participated at the hearing: Chairman

Ruland J. Gill, Jr., Michael R. Brown, Carl F. Kendell, Chris D. Hansen, Susan S. Davis and Gordon L. Moon. Board Member Kelly L. Payne was unable to attend. The Board was represented by Fredric J. Donaldson, Esq., Assistant Attorney General.

Testifying on behalf of Petitioner Newfield Production Company (“Newfield”) were Robert N. Miller, II – Senior Landman, Jill Thompson – Geologist, and Mike Jensen – Engineering Advisor. They were recognized by the Board as experts in petroleum land management, geology and petroleum engineering, respectively, for purposes of this Cause. Frederick M. MacDonald, Esq., of and for MacDonald & Miller Mineral Legal Services, PLLC, appeared as attorney for Newfield.

The Division of Oil, Gas and Mining (the “Division”) did not file a staff memorandum in this Cause but participated in the hearing. Douglas J. Crapo, Esq., Assistant Attorney General, appeared as attorney for the Division. The Board also asked questions of Dustin Doucet, Petroleum Engineer for the Division. Mr. Crapo made a statement expressing the Division’s support for the granting of Newfield’s Request for Agency Action filed on September 8, 2014 in this Cause (the “Request”) as conformed to the testimony and other evidence provided at the hearing.

No other party filed a response to the Request and no other party appeared or participated at the hearing.

The Board, having considered the testimony presented and the exhibits received into evidence at the hearing, being fully advised, and for good cause, hereby makes the following findings of fact, conclusions of law and order in this Cause.

FINDINGS OF FACT

1. Newfield is a Texas corporation with its principal place of business for Rocky Mountain operations in Denver, Colorado. Newfield is duly qualified to conduct business in the State of Utah, and is fully and appropriately bonded with all relevant Federal, Indian and State of Utah agencies.

2. Newfield seeks the establishment of the following respective Duchesne County, Utah lands (collectively the "Subject Lands") as permanent drilling units for the production of oil, gas and associated hydrocarbons from the Upper Wasatch, defined for purposes of this Cause as follows:

the base of the Uteland Butte Member of the Lower Green River formation to the top of the Wasatch Red Beds, being the stratigraphic equivalent of the interval from 8,765 feet to 9,967 feet MD as identified in the Dual Induction Log run on March 7, 1972 in the JW Accawinna # 1 Well located in the NE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 13, T3S, R3W, USM,

(the "Subject Formation"), from long lateral horizontal wells:

Township 3 South, Range 1 West, USM

Sections 6 and 7

Township 3 South, Range 2 West, USM

Sections 5 and 8

Sections 6 and 7

Sections 28 and 33

Township 3 South, Range 3 West, USM

Sections 5 and 8

Sections 13 and 24

Sections 14 and 23

(each singularly the “Drilling Unit” and collectively the “Drilling Units”).

3. The oil, gas and associated hydrocarbons in each Drilling Unit are owned as follows:

Sections 6 and 7, T3S, R1W – Fee and Federal (Bureau of Land Management (“BLM”) administered)

Sections 5 and 8, T3S, R2W: Fee, Ute Tribal and State (School and Institutional Trust Lands Administration (“TLA”) administered)

Sections 6 and 7, T3S, R2W: Fee, Ute Tribal, Allotted and Federal (BLM administered)

Sections 28 and 33, T3S, R2W: Fee, Ute Tribal and Allotted

Sections 5 and 8, T3S, R3W: Fee, Ute Tribal and Allotted

Sections 13 and 24, T3S, R3W: Fee, Allotted and State (Division of Forestry, Fire and State Lands (“DFFSL”) administered)

Sections 14 and 23, T3S, R3W: Fee, Ute Tribal and Allotted

Newfield is the majority working interest owner in each of the Drilling Units.

4. By Order entered on September 20, 1972 in Cause No. 139-8 (the "139-8 Order"), the Board established sectional (640-acre or substantial equivalent) drilling units for the production of oil, gas and associated hydrocarbons from the Lower Green River-Wasatch formations, defined as follows:

the interval from the top of the Lower Green River formation (TGR₃ marker) to the base of the Green River-Wasatch formations (top of Cretaceous), which base is defined as the stratigraphic equivalent of the Dual Induction Log depths of 16,720 feet in the Shell-Ute 1-18B5 well located in the S $\frac{1}{2}$ NE $\frac{1}{4}$ of Section 18, Township 2 South, Range 5 West, U.S.M., and 16,970 feet in the Shell-Brotherson 1-11B4 well located in the S $\frac{1}{2}$ NE $\frac{1}{4}$ of Section 11, Township 2 South, Range 4 West, U.S.M.,

for numerous lands in the Western Altamont and Cedar Rim fields, including subject Sections 5 and 6 of T3S, R3W, USM. Under the original 139-8 Order, only one well may produce on each such unit so established, which must be located in the center of the NE $\frac{1}{4}$ with a tolerance of 660 feet in any direction; provided that an exception to said tolerance may be granted administratively without a hearing where a topographical exception is deemed needed.

5. By Order entered on October 27, 1983 in Cause No. 131-51 (the "131-51 Order"), the Board established sectional (640-acre or substantial equivalent) drilling units

for the production of oil, gas and associated hydrocarbons from the Lower Green River and Wasatch formations, defined as follows:

That interval below the stratigraphic equivalent of 9,600 feet depth in the "E" Log of the Carter #2 Bluebell well located in the SW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 3, Township 1 South, Range 2 West, U.S.M. (which equivalence is the depth 9,530 feet of the SP curve, Dual Induction Log, run March 15, 1968, in the Chevron #1 Blanchard Well located in the NW $\frac{1}{4}$ SE $\frac{1}{4}$ of said [Section 3]), to the base of the Green River-Wasatch formations,

for numerous lands in the south-central portion of the greater Altamont-Bluebell field, including subject Sections 6 and 7 of T3S, R1W, USM. Under the original 131-51 Order, only one well may produce on each such unit so established, which must be located no closer than 1,320 feet from the exterior boundary of any governmental section; provided, that an exception to said 1,320-foot limitation may be granted administratively without a hearing where a topographical exception is deemed necessary.

6. By Order entered on May 9, 2012 in Cause No. 139-90 (the "139-90 Order"), the Board first extended the 139-8 Order to numerous lands within the area Newfield refers to as the "Central Basin" area which were previously unspaced, including subject Sections 5 through 8, 28, and 33 of T3S, R2W, USM, and Sections 13, 14, 23, and 24 of T3S, R3W, USM, to create sectional (640-acre) drilling units for Lower Green River-Wasatch production, and second to modify the 139-8 and 131-51 Orders to allow up to four (4) producing Lower Green River-Wasatch formation wells, whether all vertical, all horizontal, or a combination of both, upon the drilling units, to be drilled at

the option of the operator and with the operator's full discretion as to the development of the hydrocarbon reserves, provided each well shall not be closer than 1,320 feet from an existing unit well completed in and producing from the formation and no closer than 660 feet from the drilling unit boundary. The Board also expressly eliminated any first well siting requirements under the original 139-8 and 131-51 Orders.

7. By Order entered on November 26, 2013 in Cause No. 139-109 (the "139-109 Order"), the Board modified the 139-90 Order as relating to subject Section 23 of T3S, R3W, USM, among other lands, to authorize the drilling, on a pilot basis, of up to eight (8) vertical or directionally drilled wells upon the sectional drilling unit, provided no producing interval of a well so authorized may be located closer than 660 feet to a sectional boundary or to another well producing from the Lower Green River-Wasatch formations. The Board required that, within 13 months after entry of the Order, Newfield report back to the Board with any available information concerning the success or failure of the pilot program.

8. Pursuant to the 139-8, 131-51 or 139-90 Orders, or the general well siting rule (Utah Admin. Code Rule R649-3-2), the following vertical or directionally drilled wells have been drilled on the Subject Lands and produce in part from the Subject Formation:

No short lateral horizontal wells producing from the Subject Formation have been drilled on any of the Subject Lands, and no additional vertical or directionally drilled wells have been drilled on the subject Section 23, T3S, R3W, USM, lands per the 139-109 Order.

9. With respect to the Subject Lands, the Subject Formation is a 1,000 – 1,400 foot thick interval of interbedded lacustrine carbonate, shale and discontinuous sandstone. The depth to the top is typically 8,000 – 10,500 feet MD in the Central Basin,

and lies directly below the base of the Uteland Butte Member (Lower Green River interval) as defined by Newfield. The base of the Subject Formation is defined by Newfield at the Wasatch Red Beds stratigraphic marker. At this marker, the Wasatch formation lithology changes from a predominantly lacustrine system to a predominantly fluvial/alluvial system. Carbonate markers within the Subject Formation can be correlated across the Central Basin, but the lacustrine sand bodies are highly discontinuous and can be challenging to target with a vertical well program. Within the Central Basin, the Subject Formation also maintains an overprint of natural fracturing that, when accessed, provides production enhancements. The Subject Formation is an attractive horizontal candidate when utilizing hydraulic fracture enhancement as it communicates across stratigraphic complexity and effectively accesses the existing throughgoing natural fracture networks. A horizontal lateral will encounter and access several distinct reservoirs that could not be accessed in widely-spaced vertical well bores.

10. The Board has previously authorized, on a pilot basis, five (5) special 1,280-acre (or substantially equivalent combination of lots and quarter-quarter sections) drilling units for the Subject Formation, and the drilling and production of up to eight (8) long lateral horizontal wells thereon, within other portions of the Central Basin area in its Orders entered on May 9, 2013 in Cause No. 139-103, and on November 26, 2013 in Cause No. 139-110, both as modified by its order entered on June 13, 2014 in Cause No.

139-117 (collectively the "SXL Pilot Orders"). No producing interval of the authorized horizontal lateral may be located closer than 660 feet to the boundaries of the special drilling units, and no closer than 660 feet laterally when closer than 200 feet vertically to another horizontal lateral within the special drilling unit without an exception location approval. With respect to horizontally stacked laterals within the special drilling unit, there is no inter-well setback distance laterally required provided the stacked horizontal laterals are located at least 200 feet or greater apart in vertical distance. In addition, the Board required Newfield to report back to the Board no later than June 14, 2015 on the results of the pilots.

11. To date, Newfield has drilled and is producing five (5) long lateral Upper Wasatch wells pursuant to the SXL Pilot Orders, and three (3) additional wells anticipated to be drilled in the fourth quarter of 2014. Although the data from those wells is still preliminary, Newfield has concluded, based thereon and from other Central Basin short lateral Subject Formation wells and studies, that:

- a) micro-seismic studies, combined with drilling-induced fracture measurements, reflect a dominant fracture orientation average of N 51.5 W (308.5°) and an estimated average effective fracture half-length of 334 feet;
- b) the average estimated original oil in place ("OOIP") for each of the Drilling Units is 84.4 MMBO;
- c) production from the Upper Wasatch horizontal short lateral wells to date is extrapolated to generate a long lateral type curve of 850 MBO estimated ultimate

recovery ("EUR") based on a 330-ft. N/S setback. This 850 MBO type curve fits the actual long lateral production data to date;

- d) utilizing the OOIP and EUR figures, and a 10% recovery factor, up to eight (8) long horizontal wells, together with the existing vertical wells, will drain an average of approximately 1,049 acres across the seven Drilling Units; and
- e) long lateral horizontal wells drilled in the Drilling Units should be economic (estimated 37% rate of return with a 2.32 year payout).

As a consequence, the requested in-fill authorization for up to eight (8) long lateral wells is justified. The Board remains cognizant that the data generated from the pilot areas is still preliminary and requires further confirmation and delineation both spatially and vertically. Additionally, the Board is cognizant of the practical logistical reasons justifying approval of the Drilling Units, such as long permitting times (6-12 months) and long term planning necessary for efficient and economic well pad and infrastructure design.

12. Based on the micro-seismic studies and drilling-induced fracture measurements, a reduced setback from the North and South boundaries of the Drilling Units from 660 feet to 330 feet should result in an approximate additional 60 MBO per Drilling Unit without adversely affecting the correlative rights of the owners in the adjacent sections.

13. The micro-seismic and reserve recovery studies have also demonstrated that maintaining a 1,320-foot setback from the existing vertical wells should result in little or

no communication between wells and therefore not adversely affect the existing correlative rights of the owners in production from those existing wells.

14. The exhibits and testimony received into evidence also indicate that maintaining the other setbacks established in the SXL Pilot Orders should minimize, if not eliminate, any communication between wells and is just and reasonable under the circumstances.

15. The exhibits and testimony received into evidence support Newfield's conclusion that vertical or directionally drilled wells may not recover as much resource from the Subject Formation or be as economical as long lateral horizontal drilling in this portion of the Central Basin. Partially vacating the 139-109 Order as relating to subject Section 23, T3S, R3W, USM, is therefore appropriate.

16. Newfield represented that, where feasible, multi-well pads may be utilized. The requested long lateral horizontal well density will lend itself to the use of multi-well pads which, in turn, will help minimize surface impacts.

17. In Newfield's Central Basin experience, Federal, Tribal and/or Allotted lands, whether by regulation and guideline or Federal agency practice, will require a Board order establishing the requested drilling units in order to allow conforming communitization agreements to be executed and approved.

18. A copy of the Request was mailed, postage pre-paid, certified with return receipt requested, and properly addressed to all working interest owners (including unleased owners) within the proposed drilling units, and to the DFFSL, the TLA, Bureau of Indian Affairs – Uintah & Ouray Agency (“BIA”), and the BLM, being the supervising governmental agencies having jurisdiction over the State, Federal, Tribal and Allotted minerals. The mailings were sent to said parties at their last addresses disclosed by the relevant DFFSL, TLA, BIA, BLM and Duchesne County realty records.

19. Notice of the filing of the Request and of the hearing thereon was duly published in the Salt Lake Tribune and the Deseret Morning News on October 5, 2014 and the Uintah Basin Standard on October 7, 2014.

20. The vote of the Board Members present and participating in the hearing on this Cause was unanimous (6-0) in favor of granting the Request.

CONCLUSIONS OF LAW

1. Due and regular notice of the time, place and purpose of the hearing was properly given to all parties whose legally protected interests are affected by the Request in the form and manner as required by law and the rules and regulations of the Board and Division.

2. The Board has jurisdiction over all matters covered by the Request and all interested parties therein, and has the power and authority to render the order herein set forth pursuant to Utah Code Ann. §§ 40-6-5(3)(b) and 40-6-6.

3. The Subject Formation as underlying the Subject Lands constitutes a “common source of supply” as that phrase is defined in the Utah Code Ann. § 40-6-2(19).

4. Up to eight (8) “long” (up to 9,900 feet in length) lateral horizontal wells are required to efficiently and economically drain each Drilling Unit and to prevent waste (by leaving resources in the ground).

5. Creation of the Drilling Units for the Subject Formation with the provisos outlined below is fair, reasonable and justified under the circumstances.

6. Correlative rights will be protected by the virtue of the setbacks outlined below.

7. The relief granted hereby will result in consistent and orderly development and the greatest recovery of oil, gas and associated hydrocarbons from the Subject Formation and underlying the Subject Lands, prevent waste and adequately protect the correlative rights of all affected parties.

8. Newfield has sustained its burden of proof, demonstrated good cause, and satisfied all legal requirements for granting of the Request.

ORDER

Based upon the Request, testimony and evidence submitted, and the findings of fact and conclusions of law stated above, the Board hereby orders:

1. The Request in this cause is granted.
2. The 139-109 Order, only insofar as it pertains to Section 23, T3S, R3W, USM, is hereby vacated.
3. The 139-8, 131-51 and 139-90 Orders are hereby modified to establish 1,280-acre (or substantial equivalent combination of lots and quarter-quarter sections) delineation drilling units for the production oil, gas and hydrocarbons for the Upper Wasatch as defined in Findings of Fact No. 2 above, for long lateral horizontal wells comprised of subject Sections 6 and 7, T3S, R1W, USM, Sections 5 and 8, 6 and 7, and 28 and 33, T3S, R2W, USM, and Sections 5 and 8, 13 and 24, and 14 and 23, T3S, R3W, USM, respectively, and authorizing the drilling and production of up to eight (8) long lateral horizontal wells upon each such drilling unit.
4. No producing interval of the authorized horizontal lateral may be located closer than 330 feet to the north and south, and 660 feet to the east and west, boundaries of said drilling unit, no closer than 1,320 feet to an existing vertical or directionally drilled well producing from the Upper Wasatch, as defined in Findings of Fact No. 2, and no closer than 660 feet laterally when closer than 200 feet vertically to another horizontal

lateral within the drilling unit, without obtaining an exception location approval in accordance with Utah Admin. Code Rule R649-3-3. With respect to horizontally stacked laterals within the drilling unit, there shall be no inter-well setback distance laterally required provided the stacked horizontal laterals are located at least 200 feet or greater apart in vertical distance.

5. The surface location of any authorized horizontal well not only may be anywhere upon the drilling unit, but may also be located off the drilling unit presuming proper surface and sub-surface authorization for such a location has been obtained from the owners and the well will be cased and cemented to the 330-foot drilling unit setback within the drilling unit as set forth in (4) above, both to be evidenced and satisfied by a self-certification to such effect executed by the operator of the drilling unit and filed with the Division, and the other setbacks for the wells set forth in 4 above are maintained.

6. Any horizontal well drilled pursuant hereto may not be plugged back or recompleted to produce from any other formation other than the Upper Wasatch (as defined in Findings of Fact No. 2), and no additional wells located upon the Subject Lands may be perforated to produce from the Upper Wasatch (as defined in Findings of Fact No. 2), without further authorization from the Board.

7. The 139-90 Order shall continue to govern production allocation from the existing vertical or directionally drilled wells producing from the Upper Wasatch (as defined in Findings of Fact No. 2), *i.e.*, shall continue on a sectional basis.

8. The drilling units established herein are declared to be “permanent” for purposes of any authorized horizontal wells drilled thereon.

9. Pursuant to Utah Admin. Code Rules R641 and Utah Code Ann. § 63G-4-204 to 208, the Board has considered and decided this matter as a formal adjudication.

10. This Order is based exclusively on evidence of record in the adjudicative proceeding or on facts officially noted, and constitutes the signed written order stating the Board’s decision and the reasons for the decision, all as required by the Administrative Procedures Act, Utah Code Ann. § 63G-4-208 and Utah Administrative Code Rule R641-109.

11. Notice re: Right to Seek Judicial Review by the Utah Supreme Court or to Request Board Reconsideration: As required by Utah Code Ann. § 63G-4-208(e) - (g), the Board hereby notifies all parties in interest that they have the right to seek judicial review of this final Board Order in this formal adjudication by filing a timely appeal with the Utah Supreme Court within 30 days after the date that this Order issued. Utah Code Ann. §§ 63G-4-401(3)(a) and 403. As an alternative to seeking immediate judicial review, and not as a prerequisite to seeking judicial review, the Board also hereby notifies

parties that they may elect to request that the Board reconsider this Order, which constitutes a final agency action of the Board. Utah Code Ann. § 63G-4-302, entitled, “Agency Review – Reconsideration,” states:

(1)(a) Within 20 days after the date that an order is issued for which review by the agency or by a superior agency under Section 63G-4-301 is unavailable, and if the order would otherwise constitute final agency action, any party may file a written request for reconsideration with the agency, stating the specific grounds upon which relief is requested.

(b) Unless otherwise provided by statute, the filing of the request is not a prerequisite for seeking judicial review of the order.

(2) The request for reconsideration shall be filed with the agency and one copy shall be sent by mail to each party by the person making the request.

(3)(a) The agency head, or a person designated for that purpose, shall issue a written order granting the request or denying the request.

(b) If the agency head or the person designated for that purpose does not issue an order within 20 days after the filing of the request, the request for reconsideration shall be considered to be denied.

Id. The Board also hereby notifies the parties that Utah Admin. Code Rule R641-110-100, which is part of a group of Board rules entitled, “Rehearing and Modification of Existing Orders,” states:

Any person affected by a final order or decision of the Board may file a petition for rehearing. Unless otherwise provided, a petition for rehearing must be filed no later than the 10th day of the month following the date of signing of the final order or decision for which the rehearing is sought. A copy of such petition will be served on each other party to the proceeding no later than the 15th day of the month.

Id. See Utah Admin. Code Rule R641-110-200 for the required contents of a petition for Rehearing. If there is any conflict between the deadline in Utah Code Ann. § 63G-4-302 and the deadline in Utah Admin. Code Rule R641-110-100 for moving to rehear this matter, the Board hereby rules that the later of the two deadlines shall be available to any party moving to rehear this matter. If the Board later denies a timely petition for rehearing, the party may still seek judicial review of the Order by perfecting a timely appeal with the Utah Supreme Court within 30 days thereafter.

The Board retains continuing jurisdiction over all the parties and over the subject matter of this cause, except to the extent said jurisdiction may be divested by the filing of a timely appeal to seek judicial review of this order by the Utah Supreme Court.

For all purposes, the Chairman's signature on a faxed copy of this Order shall be deemed the equivalent of a signed original.






