Pursuant to the Petition of Conoco Inc. (the "Petitioner") this Cause came on for hearing before the Utah Board of Oil, Gas and Mining (the "Board") on Wednesday, January 24, at the hour of 1:30 p.m. The following Board members were present and participated at the hearing:

Attending and participating on behalf of the Division of Oil, Gas and Mining (the "Division") were James W. Carter, Director; Frank Matthews, Petroleum Engineer; and Brad Hill, Petroleum Geologist. The Board was represented by Patrick O'Hara and the Division was represented by Thomas A. Mitchell, Assistant Attorneys General.

The United States Bureau of Land Management ("BLM"), was represented by Robert Hendericks, Chief, Branch of Fluid Minerals, Utah State Office and Jerry Kenczka, Petroleum Engineer, Vernal District Office.

The Ute Indian Tribe was represented by Robert Thompson, III, attorney at law.

A statement was made to the Board by Collis Chandler, III on behalf of Chandler & Associates, Inc.

Testifying on behalf of Petitioner was Robert W. Hardin, Senior Land Advisor; Robert Wentz, Geologist; and David Harwell, Petroleum Engineer. The Petitioner was represented by Thomas W. Bachtell of Pruitt, Gushee & Bachtell.

The Division, BLM, Ute Indian Tribe and Chandler & Associates, Inc. made statements in support of the Petition. No statements were made in opposition to the Petition.

The Board having considered the testimony presented and the exhibits received at the hearing, being fully advised, and for good cause appearing, hereby makes the following findings of fact and order.

FINDINGS OF FACT

1. Due and regular notice of the time, place and purpose of the hearing was given to all interested parties in the form and manner as required by law and the rules of the Board.

2. The Board has jurisdiction over the matters covered by said Petition, over all interested parties therein, and has

jurisdiction to make and promulgate the Order hereinafter set forth.

3. Petitioner is the owner of working interests and operating rights under oil and gas leases covering the following described 320-acre, more or less, tracts of land located in Uintah County, Utah; to wit:

- a. Township 8 South, Range 21 East, SLM
Section 35: S $\frac{1}{2}$

(containing 320.00 acres, more or less)
- b. Township 8 South, Range 21 East, SLM
Section 36: S $\frac{1}{2}$

(containing 320.00 acres more or less)
- c. Township 8 South, Range 22 East, SLM
Section 31: N $\frac{1}{2}$

(containing 319.17 acres, more or less)
- d. Township 8 South, Range 22 East, SLM
Section 31: S $\frac{1}{2}$

(containing 319.55 acres, more or less)
- e. Township 9 South, Range 21 East, SLM
Section 1: N $\frac{1}{2}$

(containing 331.59 acres, more or less)
- f. Township 9 South, Range 21 East, SLM
Section 2: N $\frac{1}{2}$

(containing 326.64 acres, more or less)
- g. Township 9 South, Range 22 East, SLM
Section 6: N $\frac{1}{2}$

(containing 306.09 acres, more or less)

4. Petitioner has drilled a well in each of the seven (7)

320-acre, more or less, tracts of land described in paragraph 3 above and has completed each well within the geologic formation described as follows:

That interval below the stratigraphic equivalent of 1,450 feet down to and including the stratigraphic equivalent of 4,772 feet as shown on the induction electric log of the Chapita Wells Unit Well No. 5 located 1908 feet from the south line and 2360 feet from the west line of the NE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 22, Township 9 South, Range 22 East, SLM, Uintah County, Utah.

hereinafter referred to as the "Green River formation."

5. The names and legal locations for each of the seven (7) wells drilled and completed by Petitioner in the Green River formation are as follows:

- a. Ute Tribal #35-51, 660' FSL 1980' FEL, Sec. 35, T8S, R21E, SLM
- b. Ute Tribal #36-53, 794' FSL 2148' FWL, Sec. 36, T8S, R21E, SLM
- c. Federal #31-57, 2110' FNL 631' FEL, Sec. 31, T8S, R22E, SLM
- d. Ute Tribal #31-55A, 660' FSL 660' FWL, Sec. 31, T8S, R22E, SLM
- e. Ute Tribal #1-54, 626' FNL 1947' FEL, Sec. 1, T9S, R21E, SLM
- f. Ute Tribal #2-50, 460' FNL 1980' FEL, Sec. 2, T9S, R21E, SLM
- g. State #6-56, 990' FNL 660' FEL, Sec. 6, T9S, R22E, SLM

6. Natural gas and associated hydrocarbons from the Green River formation can be produced in commercial quantities from the wells described in paragraph 5 above.

7. One well producing natural gas from the Green River formation can efficiently and economically drain an area of 320 acres, more or less, in the tracts of land described in paragraph 3 above.

8. To date, there is no evidence that the production of natural gas from the Green River formation will adversely affect the production of oil from nearby wells within the same formation, but based upon some concern expressed to the Board in a letter from Chandler & Associates, Inc., Petitioner agreed to submit semi-annual reports to the Division reviewing the impact, if any, of the continued production of the natural gas on the production of this oil.

9. The production of natural gas and associated hydrocarbons from 320-acre, more or less, lay down drilling units from the lands and wells described above in paragraphs 3 and 5 respectively will prevent waste, adequately protect correlative rights of all affected parties, and is just and reasonable under the circumstances.

ORDER

After considering the testimony and evidence presented at the hearing along with the comments received from the representatives of the Division, BLM, Ute Indian Tribe and Chandler & Associates, Inc., the Board enters the following order:

A. There is hereby established 320-acre, more or less, lay down drilling units covering the tracts of land described in paragraph 3 above for the production of natural gas and associated hydrocarbons from the Green River formation as that formation is described in paragraph 4 above.

B. The permitted well for each drilling unit is that well listed in paragraph 5 above which is legally located within the exterior boundary of the respective drilling unit.

C. Petitioner shall submit semi-annual reports to the Division on or before July 31 and January 31 of each calendar year. The reports shall review the production of oil from wells near the drilling units. Each report shall provide relevant technical information which addresses the economic impact of the continued production of natural gas from the drilling units on the production of oil from nearby wells producing from the Green River formation.

D. The Board retains continuing jurisdiction over all of the parties and over the subject matter of this Cause.


